

Restlawn Memorial Gardens

Ground Gardens Floral Regulations

Clean up: The cemetery has two scheduled clean ups per year when ALL decorations will be removed.

Spring Clean-Up: March 1st – March 15th (Weather permitting)

Fall Clean-Up: October 1st – October 15th (Weather permitting)

1. Cut flowers are permitted anytime providing they are in a bronze vase.
2. “Add On” granite and vase units are available to order at the cemetery office.
3. **March 16th to October 1st:** Artificial or cut flowers are permitted, providing that they are in the bronze vase attached to the memorial. Vases are to be inverted by October 1st to avoid freeze damage. Any vases that are removed by the family, shall be the family’s responsibility and not that of the cemetery.
4. Urns and jardinières are not permitted at any time. The only permitted live flower container is the green metal basket that are 9” in diameter and 10” high, with a handle that extends 14” above the top of the basket. **ALL BASKETS MUST BE CLEARLY MARKED WITH THE NAME OF THE DECEASED. THIS IS THE RESPONSIBILITY OF THE LOT OWNER.** Restlawn Memorial Gardens shall have the right to remove any basket at any time if it is not maintained. Baskets may be on the grave from Memorial Day through October 1. Those remaining on graves after that date will be removed by the groundskeepers and families may pick them up by the office.
5. Glass and earthenware containers are not permitted.
6. Watering of flowers and decorations placed by the family shall be the family’s responsibility and not that of Restlawn Memorial Gardens.
7. Winter decorations, such as grave blankets and wreaths, are permitted between October 16 and March 1. Decorations must be securely attached to a stake or easel of appropriate height and pushed into the ground. A label with the name of the deceased must be attached. Winter decorations may be purchased by visiting Restlawn Memorial Garden’s Office.
8. Restlawn Memorial Gardens has the authority to remove any items which are contrary to the regulations or which, in its judgment, have deteriorated and no longer contribute to the beauty and dignity of the cemetery.
9. Restlawn Memorial Gardens assumes no liability for lost or stolen baskets or decorations.

10. NOT ALLOWED ON GRAVES:

GLASS CONTAINERS, WIRE, ROCKS, STONES, EDGING, FENCING, STATUES, FIGURINES, SCULPTURES, SOLAR LIGHTS, BALLOONS, LAWN ORNAMENTS, WOOD CHIPS, PERENNIALS

Any other items not permitted will be removed.

INTERIOR AND EXTERIOR MAUSOLEUM FLORAL REGULATIONS

CHAPEL OF FAITH:

Please consider the other families of loved ones near yours when placing personal items. The mausoleum should be a place of peace, honor, and quiet reflection. Items should be appropriate and in keeping with the dignity of the Chapel.

Only silk flowers are permitted in the interior Mausoleum. These must be placed in a Crypt Front Vase. Vases are available for purchase at the Cemetery Office.

Casket Sprays from a recent entombment are permitted until deemed unsightly, at which time they will be removed by the maintenance staff if not removed by the family.

Any additional seasonal arrangements are required to be silk or dried. They may be placed beginning the Friday before and ending the following week on Monday (7-10 days) after each of the four special occasions: EASTER SUNDAY, MOTHER'S DAY, MEMORIAL DAY, AND FATHER'S DAY. These arrangements will be removed by the maintenance staff on that Monday if not removed by the family. These may be picked up within a week by the Maintenance building.

Only one (1) floral arrangement is permitted per crypt. This will prevent the cluttered look and allow space for everyone. If you are bringing in a seasonal arrangement, please take your other arrangement home for that period of time.

Nothing may be taped to the Crypt Front. Permanent Cameo Photos may be purchased in the cemetery office.

EXTERIOR MAUSOLEUM

Exterior crypt fronts that have the mounted 5" Bronze Vase are permitted to use silk arrangements as described above, or fresh cut flowers. Watering of these vases is the responsibility of the family. Vases are available to purchase at the cemetery office.

Exterior Crypts/Niches are also permitted to use the Green Baskets. See the regulations for GROUND GARDENS FLORAL REGULATIONS.

Nothing may be taped to the Crypt Front. Permanent Cameo Photos may be purchased in the cemetery office.
