## **General Price List**

These prices are effective as of September 1, 2022, and are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items that you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any item for which you did not specifically ask, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

“The survivor of the deceased who is handling the funeral arrangements, or the responsible party, is entitled to receive, prior to the drafting of any contract, a copy of any agreement that has been signed and paid for, in full or in part, by or on behalf of the deceased, and that is in the possession of the funeral establishment.”

“THERE IS NO EVIDENCE THAT ANY CASKET REPRESENTED AS HAVING PROTECTIVE FEATURES, WHICH MAY INCLUDE A GASKET, WILL PRESERVE HUMAN REMAINS.”

### **MINIMUM SERVICES OF THE FUNERAL DIRECTOR AND STAFF:**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains). This fee includes the following:

Personnel available 24 hours a day, 365 days a year to respond to initial call.

Arrangement conference.

Coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased.

Clerical assistance in the completion of various forms associated with a funeral/cremation

Faxing/internet fee to newspapers, physicians, health departments, and various others.

Securing and recording the death certificate and disposition permit. Contract processing fee.

Also covers overhead, such as facility maintenance, equipment and inventory costs, insurance and administration expenses, and governmental compliance.

### **PREPARATION OF THE BODY:**

*Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.*

Embalming (California law requires embalming or refrigeration if deceased is held for more than 24 hours after time of death)

Refrigeration (*California state law requires refrigeration of an unembalmed body after 24 hours*). \$550.00  
(This charge is for a three day period, \$100.00 for each day thereafter.)

### **Other preparation:**

bathing, disinfecting and handling of the deceased

Special care for Autopsy

Restorative Care (where necessary)

Dressing, casketing and/or cosmetizing of the deceased

## **USE OF FACILITIES AND STAFF:**

Use of facilities and staff services for visitation (public/private/or identification per day). *(Our services include set-up of visitation area, placement of casketed remains, display of floral arrangements, supervision of and attendance during the visitation).*

Use of the facilities and staff services for funeral service in our chapel. *(Our services include coordinating the funeral arrangements, supervision of funeral, display of floral arrangements, and staff to assist with funeral ceremony).*

Staff services for funeral service in other facility. *(Our services include coordinating the funeral arrangements, supervision of funeral display of floral arrangements and staff to assist with funeral ceremony).*

Use of facilities and staff services for memorial service (without remains present) at other facility. *(Our services include coordinating the memorial service arrangements, supervision of the memorial service, display of floral arrangements and staff to assist with the services).*

Equipment and staff services for graveside service. *(Our services include accompaniment of remains to cemetery, supervision of graveside service, display of floral arrangements and staff to assist with services, sound system, register stand provided)*

Additional charge for use of facilities for evening service.

Additional charge for use of facilities and staff on Saturday, Sunday, or Holidays.

## **TRANSPORTATION:**

Transfer of deceased from place of death to mortuary (within a 30 mile radius).  
*Additional distance will be charged at \$3.00 per loaded mile.*

Funeral vehicle (e.g. Hearse) (within a 30 mile radius).  
*Additional distance will be charged at \$3.00 per loaded mile.*

Flower car/Service vehicle (within 30 mile radius).  
*Additional distance will be charged at \$3.00 per loaded mile.*

Family vehicle (e.g. Limousine) (within 30 mile radius).  
*Additional distance will be charged at \$3.00 per loaded mile.*

Second removal attendant (after 5pm only if needed)

Transportation to Los Angeles Airport (Nearest air freight)

*This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected. We charge you for our services in buying items except where prohibited by state law.*

## **FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME:**

This charge includes removal of remains, limited services of staff, necessary authorizations, embalming, use of preparation room and local transportation (excluding shipping charges and shipping container). This charge does not include use of facilities and staff for visitation or ceremonies.

**RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME:**

This charge includes limited services of staff, transportation of remains to cemetery or crematory. This charge does not include visitation or ceremonies, nor transportation from major airport.

**DIRECT CREMATIONS:**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).

The containers we provide are: We offer a selection of alternative containers, including containers made of wood, fiberboard, other composition materials (with or without an outside covering).

Our charges for direct cremation (without ceremony) include: Removal of remains within 30 mile radius, local transportation to crematory, refrigeration of remains, necessary authorizations, and limited services of staff. Additional charges apply for night, holiday, home and weekend removal, second staff member if necessary for removal. *This charge does not include any visitation, rites or ceremonies.*

Direct cremation with container provided by purchaser

Direct cremation with alternative container made of fiberboard (crematory approved)

Crematory fee, cash advanced to licensed crematory/State of Ca. Regulatory Fee

**IMMEDIATE BURIAL:**

Our charges for immediate burial (without any rites or ceremonies at the chapel, graveside or elsewhere) include: Removal of remains, limited services of staff, transportation to cemetery.

Immediate burial with container provided by purchaser (all such containers must meet any applicable state and cemetery requirements).

Immediate burial with minimum casket.

Immediate burial with casket purchased from our funeral home (in addition to the cost of the casket).

Regulation for the cremation (Alternative) container is also provided in the Rental Casket that is required and included in the rental cost.

 Witness of cremation process (cash advance as to crematory charge)  
 Refrigeration fee after three days @ \$100.00 per day.
