Bishop Major was an excellent event planner. He was highly sought after to plan weddings, birthday celebrations, and other special events. He also frequently planned and organized religious celebrations.

Bishop Major was united in holy matrimony to the love of his life, Tedra K. Smith, in 1996. God blessed their union with a son, Caleb Leman Major, who was born on September 25, 1997.

Bishop Major loved the Lord and the church from childhood, which was evidenced by his insistence on "playing church" with his cousins and friends. Of course, he would always be the preacher. This was God's sign of preparing him to become a preacher of the gospel of Jesus Christ.

Bishop Major was a gentle soul who consistently demonstrated his Christian values by loving and serving humanity. From his childhood and throughout his life, he passionately gave of himself for the good of others. His sister, Katina Major Anderson, recounts how helpful and supportive he was after the death of her husband, Zuriel Anderson. 




























DEAR DAD


