RE: Bright Futures and Need-Based Assistance

Dear President Gaetz and Speaker Weatherford:

As you move into the final stages of budget conference, the Florida Council of 100 renews its request that all savings from the merit-based Bright Futures program be reinvested in need-based financial assistance programs, specifically the Florida Student Assistance Grant.

So far this session, the Legislature has proposed reducing Bright Futures by \$43.2 million. This reduction has been enabled by falling program enrollment, fueled by increasing eligibility requirements. As a result, many of those students who can no longer participate in Bright Futures will be left without a need-based financial safety net.

The Council of 100 applauds your making the tough decision to raise Bright Futures standards and for proposing to transfer a significant portion of the Fiscal Year 2014-15 savings to need-based assistance in the form of the Florida Student Access Grant. However, Florida is ranked 35th in the nation for percentage of aid based on need, and much more need-based assistance is required.

We therefore respectfully request that you invest at least \$43.2 million in additional need-based aid for Fiscal Year 2014-15 to compensate for the expected 2014-15 enrollment decline in Bright
