

## 80 Over 80 Exhibition Submission Guidelines

*80 Over 80* is a special exhibit that will feature 80 works of art by artists over the age of eighty. This juried show will be on view at the Bartolini Gallery at Marin Center from April 19 through June 1, 2018 and will be open to all artists living in Marin County over the age of 80. Former Marin Cultural Treasure Award winners Kathleen Lipinski, Steve Emery, and Cultural Commissioner Donna Seager Liberatore will act as jurors for this exhibit.

**1. Eligibility:** Open to all living Marin County artists, 80 years and over. All entries must be original design and must have been completed within the last five years.

**2. Entry Limit:** Five works per artist. A set (if it was designed by the artist to be displayed/sold only as a unit) is considered one entry. **There will be high competition for selection; not all entries or artists will be selected.**

**3. Application Fee:** \$5 for each entry. All application fees are non-refundable.

**4. Eligible Work: Two and three-dimensional works of art or photography**

- Two-dimensional works must be framed and have screw eyes or mirror (d-ring) hangers with braided wire. Unframed canvases must have painted/finished sides. Clip frames (glass with clips and no molding) are not acceptable.
- Wall-hung works may not exceed 8 feet in height or be of excessive weight.
- Three-dimensional works must be under 3 feet in any direction.

**5. Timeline:**

**Entry forms and entry fees due:** Thursday, March 1 by 5 pm

**Delivery of entries:** Thursday, April 12 from 9 am to Noon to Bartolini Gallery at 10 Avenue of the Flags, San Rafael, CA.

**Non-selected entries released:** Monday, April 16 from 9 am to Noon.

**Exhibit Dates:** April 19 – June 1

**Opening reception:** April 18 from 6-8 pm

**Selected entries released:** Monday, June 4 from 9 am to Noon.

**6. Sales:** Please indicate sale price or not for sale (N.F.S.) on entry form. The Marin Cultural Association will retain a 20% commission. Sales will be handled through the Department of Cultural Services. Artists will be paid by check approximately three weeks following the close of the exhibit. Sales Price may not be changed after entry form has been submitted.

**7. Liability:**

- Although reasonable efforts will be undertaken to safeguard exhibitors' property against loss, damage or theft, neither the County of Marin nor the Marin Cultural Association will be responsible for any loss, damage or theft of exhibitors' property brought on the premises during the period of the exhibit. Every precaution will be taken in the handling and exhibiting of work; we cannot guarantee the safety of any artwork not picked up on Release Day.
- Work held over 5 days after release date will become the property of the Marin Cultural Association and may be sold or donated to defray storage costs.

**8. Prizes:** Certificates will be awarded to Best of Show, First, Second, and Third place winners.

**9. Removal of Work:** Accepted works, including those sold during the exhibit, shall not be removed before release date.
