Of course, *ViV does not provide healthcare or emergency services.*

ViV will attempt to arrange services for Full Members through its group of vetted volunteers at no additional fee. However, ViV, or any organization for that matter, cannot guarantee satisfaction nor will it assume any direct or indirect responsibility or liability in any way related to the work performed by its volunteers.

ViV will take reasonable steps to protect your privacy and personal information. We expect members to also respect the privacy of other members. ViV does not tolerate harassment of its volunteers or members. Members and volunteers will avoid conflict of interest between ViV and personal, professional, or business interests.

Should you want to terminate your membership at any time in ViV, just provide five days written notice. In the unlikely event that ViV would terminate this agreement, you will receive a refund prorated for the unused portion of the year. If you terminate for cause, the ViV board will determine if you are due any partial or complete refund. Even though this agreement may have been terminated, all acknowledgements, waivers, releases, discharges, and representation provided in this agreement will remain in effect.

# VOLUNTEER APPLICATION

\_\_\_\_\_(initial) **Drivers also attest that they will maintain minimum automobile insurance coverage of \$100 K bodily injury liability per person, \$300 K total bodily injury liability and \$100 K property damage liability per accident.**

**ViV depends on its responsible volunteers. In this frame of mind, ViV volunteers agree to hold ViV harmless for any loss they may incur as a result of the services they perform, *unless their loss is specifically covered by an insurance policy maintained by ViV.***
