MVP SPRING 2019 JUNIOR TENNIS TEAM MARCH 16- MAY 18

MVP is offering a weekend Spring Junior Tennis Team for boys and girls ages 9-15. This is a great opportunity for entry level and intermediate boys and girls to get experience playing tennis against other players with similar skill levels. Note, tennis team participants must have the ability to serve and must understand scoring and basic tennis rules.

Cost: \$135 for MVP Members, \$165 non-Members.

Saturday practices at MVP will be held on the following dates:

March 16, 23

April 13, 27

May 4, 11, 18

Practices will be held from 11:45 AM to 1 PM. Practices will include match play against other MVP team members followed by fun games. Matches against local teams will be held after the practice, either at MVP or at one of the local clubs. Matches will be played in a 90-minute time frame. The match play dates will be announced in March.

Participating teams include the Orinda Country Club, Sleepy Hollow Tennis Club, Orindawoods Tennis Club, Moraga Country Club and the Berkeley Tennis Club.

Space is limited for the matches with other teams. Entry into the scheduled matches for MVP team members is based on the number of courts available and the opposing teams ability to provide enough players at a similar age or levels to MVP players. Coaches will make their best effort to include all players in at least two or more of the scheduled matches but they cannot guarantee any set number of matches per player for the program. To insure the best match-ups, MVP players may be paired with players from another team in doubles matches. This is a co-ed league, which means in some cases boys will play with and against girls.

All players are required to pay in advance and parents need to fill out and sign the attached liability form.
