***Club 50 Goes to Crystal Mountain***

**Arrival: Sunday, March 14, 2021**

**Departure: Wednesday, March 17, 2021**

For those of you with an unlimited love of skiing, but who aren't sure if you're ready for airplane travel, Club 50 will travel to Thompsonville, Michigan to ski at Crystal Mountain. Crystal Mountain has a 374-foot vertical drop and 58 runs. We will be staying 3 nights and skiing 2-3 days. As the resort is about 305 miles northeast of Chicago, Club 50 members will be responsible for their own transportation, but we will establish a sign-up system for those who want to car pool.

For those who are into alternative winter sports, Crystal Mountain offers 25 kilometers of cross-country trails, with 4 kilometers lit up for night skiing. The Michigan Legacy Art Park has a 1.6 mile snowshoe trail. Cross-country and snowshoeing gear can be rented at Crystal Mountain.

- 3-day lift ticket to Crystal Mountain ski area, Sunday thru Wednesday
- Admission to the Michigan Legacy Art Park
- Complimentary fitness classes at the fitness center, plus use of fitness center and pool
- Wine and cheese party two evenings
- Pizza party on the last night

\*Trip price is subject to change dependent upon various factors including published lift and lodging package rates and amount and ages of participants.

\*\* If you sign up without a person to room with, we make every attempt to match you with someone of the same sex (in the order you sign up). However, if another person is unavailable, you will be asked to pay the single supplement price.

If you are purchasing an **Indy Pass** for any trips, your pass is good for 2 days at Crystal Mountain, plus 25% off any additional days (a savings of \$70 off the package price). The Indy Pass is also good for 2 days at Caberfae Peaks, about a half-hour away from Crystal Mountain.

**Trip Waiver And Release Of Liability**

**THIS IS A LEGAL DOCUMENT AND A RELEASE OF LIABILITY/WAIVER OF CERTAIN LEGAL RIGHTS. READ CAREFULLY BEFORE SIGNING**

In consideration of my participation in the CHICAGOLAND CLUB 50 Trip listed above (the “**Trip**”), I [Print Participant’s Name] \_\_\_\_\_, hereby acknowledge that I am aware of and understand that any and all snowsports activities, including but not limited to skiing, snowboarding and racing (“**Snowsports**”) are hazardous activities and dangerous sports which can lead to property damage, serious injury or even death and **that injuries are a common and ordinary occurrence**. I understand and voluntarily agree to personally assume any and all of the liability and risks of Snowsports. I understand that these risks include, but are not limited to, contact with permanent and temporary fences, gates, posts, trees, snow-making equipment, lift equipment and towers, rope tows and surface lifts, light poles, signs, buildings, roads and walkways, padded and non-padded barriers and obstacles, grooming equipment, snowmobiles, and collisions with other skiers and/or snowboarders, spectators and other persons, and other natural and man-made hazards, equipment failures, exceeding one’s own abilities, the design, location, construction, inspection, maintenance, and repair of the ski area, changes in terrain, weather and snow surfaces.

Further, I agree it is solely my responsibility to determine the safety of the ski area’s facilities, including but are not limited to, ski trails and off-piste skiing and/or snowboarding, for my ability level. I acknowledge that the risks in Snowsports can be reduced by my taking lessons, by my abiding by the Skier Responsibility Code and by my using common sense.

Further, if this Trip includes travel to or through any country other than the United States (“**Foreign Country**”) at any time for any reason, I agree it is solely my responsibility to ascertain prior to the Trip that my travel to or through such Foreign Country will be acceptable to said Foreign Country, including but not limited to, my passport and/or under all laws and regulations of such Foreign Country. **I understand that laws and regulations of Foreign Countries can be and often are much different that the same laws and regulations of the United States**. By way of example only, a conviction of driving under the influence of drugs or alcohol in the United States can bar a person from admittance to Canada.
