The 2021 western ski trip for Chicagoland Club 50 is to Park City, Utah from Saturday, February 6 to Saturday, February 13. Club 50 will again be staying at the Yarrow DoubleTree by Hilton. The hotel is a short bus ride from both Park City Mountain Resort and Deer Valley Resort. These separate resorts have a total of 9,325 acres with 12% beginner, 41% intermediate and 47% advanced terrain. And, of course, Deer Valley is still skiers only, no snowboarders. Skiing at Alta, Snowbird, etc., is also available by taking regularly scheduled buses. The truly adventurous can travel from Park City to Snowbird by going over the Wasatch Mountains on skis rather than through the Salt Lake Valley on a bus. We will be staying in historic Park City, which is an old silver mining camp with lots of town activities. The hotel has a heated pool, hot tub, bar/lounge, restaurant, free internet and hot breakfast.

The price of \$1,700* includes:

- 7 nights lodging in the Yarrow Hotel, two to a room with two queen beds
- Round-trip airfare on Delta Airlines non-stop Chicago-Salt Lake City
- Round-trip transfers from Salt Lake City to Park City
- Luggage handling
- Welcome reception
- Daily hot breakfast
- 5 wine and cheese parties
- Pizza party one evening
- Driver and luggage handling gratuities
- Trip insurance

*Plus lift tickets:

5-day senior lift ticket is \$369 while an adult 5-day lift ticket is \$508. The lift passes will include 3 days at Park City and 2 days at Deer Valley. Discounts will be given to Epic and Ikon pass holders. Park City is an Epic Pass resort while Deer Valley is on the Ikon Pass. Six-day ski passes will also be available.

If you sign up without a person to room with, we make every attempt to match you with someone of the same sex (in the order you sign up). However, if another person is not available, you will be placed on a wait list and/or asked to pay the single supplement price.

THIS IS A LEGAL DOCUMENT AND A RELEASE OF LIABILITY/WAIVER OF CERTAIN LEGAL RIGHTS. READ CAREFULLY BEFORE SIGNING

In consideration of my participation in the CHICAGOLAND CLUB 50 Trip listed above (the “**Trip**”), I [Print Participant’s Name] _____, hereby acknowledge that I am aware of and understand that any and all snowsports activities, including but not limited to skiing, snowboarding and racing (“**Snowsports**”) are hazardous activities and dangerous sports which can lead to property damage, serious injury or even death and **that injuries are a common and ordinary occurrence**. I understand and voluntarily agree to personally assume any and all of the liability and risks of Snowsports. I understand that these risks include, but are not limited to, contact with permanent and temporary fences, gates, posts, trees, snow-making equipment, lift equipment and towers, rope tows and surface lifts, light poles, signs, buildings, roads and walkways, padded and non-padded barriers and obstacles, grooming equipment, snowmobiles, and collisions with other skiers and/or snowboarders, spectators and other persons, and other natural and man-made hazards, equipment failures, exceeding one’s own abilities, the design, location, construction, inspection, maintenance, and repair of the ski area, changes in terrain, weather and snow surfaces.

Further, I agree it is solely my responsibility to determine the safety of the ski area’s facilities, including but are not limited to, ski trails and off-piste skiing and/or snowboarding, for my ability level. I acknowledge that the risks in Snowsports can be reduced by my taking lessons, by my abiding by the Skier Responsibility Code and by my using common sense.

Further, if this Trip includes travel to or through any country other than the United States (“**Foreign Country**”) at any time for any reason, I agree it is solely my responsibility to ascertain prior to the Trip that my travel to or through such Foreign Country will be acceptable to said Foreign Country, including but not limited to, my passport and/or under all laws and regulations of such Foreign Country. **I understand that laws and regulations of Foreign Countries can be and often are much different that the same laws and regulations of the United States**. By way of example only, a conviction of driving under the influence of drugs or alcohol in the United States can bar a person from admittance to Canada.
