ALL-4-FUN 2016 EMPIRE, COLORADO, JULY 30 - AUGUST 6, 2016

The undersigned, for valuable consideration including the Mile-Hi Jeep Club (MHJC) permitting the below named person(s) to participate in events sponsored or held in connection with MHJC's All-4-Fun event (A4F) HEREBY RELEASE, AGREE NOT TO SUE AND FULLY DEFEND AND INDEMNIFY MHJC, it's officers, directors, agents and members, all landowners or persons/entities holding an interest in premises where any A4F event occurs and their heirs, personal representatives, assigns and/or agents (the "RELEASED PARTIES") from ANY AND ALL CLAIMS, DEMANDS, RIGHTS, CAUSES OF ACTION AND DAMAGES OF ALL TYPES, WHICH I/WE AND THE MINOR CHILDREN I HAVE REPRESENTED TO BE LEGALLY RESPONSIBLE FOR, OUR HEIRS AND ASSIGNS NOW HAVE OR LATER MAY HAVE AGAINST ANY RELEASED PARTY RESULTING FROM, ON ACCOUNT OF, ARISING OR IN ANY WAY RELATED TO A4F, ACTS OR OMISSIONS OF RELEASED PERSONS, OR PREMISES OCCUPIED OR USED IN ANY MANNER IN CONNECTION WITH A4F, AND KNOWN OR UNKNOWN CONDITIONS OF RELEASED PERSONS' PREMISES, regardless of whether such claims, rights or causes of action now exist or hereafter arise or are known or unknown, contingent or absolute, liquidated or unliquidated, foreseen or unforeseen or arise by operation of law or otherwise.

A. MY REPRESENTATIONS. I represent and warrant: (1.) I am familiar with my vehicle(s), have provided and will use all necessary safety equipment (including seat belts), have familiarized myself with the A4F event, including the premises to be used and the conditions thereof, (2.) agree that A4F is a non-commercial, volunteer sponsored event of MHJC & no part of any fee or consideration paid in connection with A4F reflects business or commercial use of premises, (3.) that use of my vehicle and participation in A4F with other persons and vehicles involves both known and unknown risks which I fully and knowingly assume as part of my agreement to this GENERAL RELEASE OF ALL CLAIMS, (4.) Should any of the below named participant(s) be a minor(s), the undersigned represents to be such minors parent or legal guardian with full authority to enter into this agreement and by signature below consents to such minor(s) riding in the within described motor vehicle and other participation in A4F, with all risks known and unknown being assumed by the signing parent or legal guardian and ALL MINOR CLAIMS BEING FULLY AND GENERALLY RELEASED as provided herein, (5.) that I and all members of my party have had the opportunity to read this GENERAL RELEASE OF ALL CLAIMS, through review or opportunity for legal counsel, fully understand it, that I am not relying on any statements or representations of any of the Released Parties, that I have been given the opportunity and sufficient time to read and ask questions regarding this GENERAL RELEASE OF ALL CLAIMS before encountering any of the risks, conditions or claims negotiated and released herein and by signature below unconditionally acknowledge and agree to the terms herein understanding that substantial rights are being given up.

B. Colorado Interpretation and Jurisdiction. As part of the consideration provided herein, the parties agree that this GENERAL RELEASE OF ALL CLAIMS shall: (1.) be made and interpreted according to the laws of Colorado without reference to choice of law principles, (2.) in the event of any claim, suit or injury arising or involving this agreement or A4F, such suit shall be filed only in a court of competent jurisdiction within the State of Colorado, (3.) to the extent the scope or any term of this agreement is unenforceable, it is the agreed intent that such other enforceable terms automatically be given affect without invalidating the agreement as a whole or the mutual intent to provide the broadest General Release enforceable under Colorado law.
