I FURTHER UNDERSTAND THE CLUB DEPENDS ON ITS MEMBERS TO PROVIDE AND LEAD CLUB TRIPS OR ACTIVITIES AND THAT THOSE MEMBERS RELY ON THE PROTECTION AFFORDED HEREUNDER. I further agree to engage in sports and activities arranged by the club in a manner that is safe to me and to those around me, to observe all applicable safety practices, and to conduct myself in a manner that will be complimentary to the sport or activity in which I am engaging. I understand and agree to abide by the club's cancellation policy in the event that I cancel my registration for any trip or activity or if the club cancels any trip or activity for all registrants. I understand that my photograph may be taken while I participate in club trips and activities, and consent to the use of any such photograph by the club for its own purposes. It is my intent that this release and waiver apply at all times, notwithstanding that my membership in the Lakeshore Ski and Sports Ski Club may have expired, lapsed, been renewed or reinstated after a period of non-membership.
