## LSSC Trip/Event Policies and Procedures

### **Announcements**

All Ski Trips are described in the eLiftline, or on the website [www.LSSC.org](http://www.LSSC.org) with an opening date for submitting applications.

### **Sign-Up**

LSSC reserves the right to decline to accept or retain any trip participant should such person's health or general deportment impede the operation of the trip or result in detriment to other participants of the trip. LSSC members have priority over nonmembers. Board members and appointed officers have priority over members during the first week after opening date. Applications require a single full payment or a specified deposit plus final payment paid by check payable to LSSC and mailed to current club Treasurer or via credit card online.

### **Payment**

Applications require a single full payment or a specified deposit plus installments paid by check or credit card online. Checks must be made payable to LSSC and show the name of the Ski Trip. An invalid check subjects the applicant to immediate removal from the Ski Trip roster and to payment of bank charges.

### **Confirmation**

Ten days after opening date, event leaders generally send confirmation letters stating whether one is confirmed or on the waiting list. Vacancies filled from the waiting list will be confirmed verbally and, if time permits, in writing. Checks of unconfirmed applicants will be destroyed.

### **Cancellation Procedures**

The confirmation e-mail states the cancellation policy for that event. Unless otherwise stated in the announcement and the confirmation letter, confirmed reservations can be cancelled at no penalty until 21 days after opening date. Subsequent cancellations will be charged up to the full trip price, as determined by the appropriate trip or activity director, depending on the loss incurred by LSSC. The minimum cancellation penalty will be \$20 for weekend trips and \$30 for major trips. The minimum cancellation penalty will be \$10 for one-day trips, events or activities. No shows will be charged up to the full trip or event price, as determined by the appropriate trip or activity director, depending on the loss incurred by LSSC.

### **Contingencies**

LSSC will not be liable for cancellation/delay of air or ground transportation due to strikes, labor disputes, weather, government actions, or other cause beyond its control. LSSC reserves the right to change mode of transportation or schedules, and participant hereby releases any claims against LSSC regarding cancellation/schedule change.
