

RULES AND FEE STRUCTURE FOR BOAT STORAGE AT SERENE LAKES

THERE ARE NO RESTRICTIONS FOR DAY USE OF APPROVED ACCESS POINTS ONLY (NO OVERNIGHT STORAGE).

STORAGE AREAS ARE NOT SECURED. SLPOA AND SLCWD ARE NOT RESPONSIBLE FOR ANY LOSS OR DAMAGE TO WATERCRAFT OR ACCESSORIES.

ALL BOATS (BOATS DEFINED AS SAILBOATS, PADDLEBOATS, PADDLEBOARDS, CANOES AND KAYAKS) MUST HAVE AN ANNUAL SLPOA STICKER FOR THE APPROPRIATE STORAGE SITE ISSUED BY SLPOA. **BOATS CAN HAVE ONLY ONE ACTIVE LOCATION STICKER PER BOAT. BOATS WITH MORE THAN ONE VALID STICKER WILL BE CONFISCATED AND STORAGE RIGHTS WILL BE REVOKED.**

ALL BOAT OWNERS MUST SIGN A HOLD HARMLESS AGREEMENT AND PAY APPROPRIATE FEES.

SEASONAL STORAGE IS DEFINED AS STORING YOUR BOAT FOR THE SEASON, WHICH IS FROM SLPOA BEACH OPENING UNTIL BEACH CLOSING.

SHORT TERM STORAGE IS DEFINED AS ANY THREE (3) DAY PERIOD. HAVING A SHORT TERM STICKER DOES NOT GUARANTEE YOU A STORAGE SPOT. SHORT TERM SPOTS ARE FIRST COME FIRST SERVED. IF NO SPOTS ARE AVAILABLE YOU MUST TAKE YOUR BOAT HOME.

LOCATIONS AND TYPE OF STORAGE:

BALES PUMP HOUSE: 84 SEASONAL SPOTS FOR CANOES AND KAYAKS.

ALLEN: 14 SHORT TERM (WITH POSSIBILITY OF SOME SEASONAL) SPOTS FOR CANOES AND KAYAKS.

BEACON/CASTLE/DULZURA: 6 SHORT TERM SPOTS EACH. YOU HAVE THE CHOICE, DEPENDING UPON AVAILABILITY, TO INTERCHANGE BETWEEN ANY OF THESE LOCATIONS. CANOES, KAYAKS, AND PADDLEBOARDS ONLY.

SWISS COURT: 30 TOTAL SPOTS. PREFERENCE IS GIVEN TO SAILBOATS AND PADDLEBOATS FOR SEASONAL SPOTS. 6 SEASONAL SPOTS FOR CANOES AND KAYAKS ARE AVAILABLE. REMAINING SPOTS WILL BE SHORT TERM FOR CANOES AND KAYAKS.

FEE STRUCTURE FOR SLPOA MEMBERS; SEASONAL STORAGE AT SWISS COURT AND BALES \$25; SHORT TERM STORAGE AT ALL OTHER LOCATIONS \$10.

FEE STRUCTURE FOR NON-SLPOA SLCWD RATEPAYERS: SEASONAL STORAGE AT SWISS COURT AND BALES \$50; SHORT TERM STORAGE AT ALL OTHER LOCATIONS \$20.

BOATS WITHOUT A STICKER, NOT STORED ON THE RACKS OR STORED FOR LONGER THAN ALLOWED WILL BE IMPOUNDED BY SLPOA. A \$20 RECOVERY FEE IS REQUIRED TO RETRIEVE YOUR BOAT. CONTACT OR CALL 426-9542 AND LEAVE A MESSAGE OR EMAIL ADMINASST@SLPOA.COM TO RECOVER YOUR WATERCRAFT. THERE WILL BE NO EXCEPTIONS.

DOCKS AND ACCESS BRIDGES ARE FOR LOADING AND UNLOADING ONLY, NO TIE UPS AT ANY TIME.
