Suppressed: The Fight to Vote

Produced by Brave New Films, this 35-minute documentary chronicles the 2018 midterm election in Georgia where people faced polling place closures, voter purges, missing absentee ballots and extreme wait times — disproportionately preventing students and people of color from voting.

UnCivil War: U.S. Elections Under Siege

Tuesday, September 22, 7:00 pm

Produced and directed by Indiana native Tom Glynn, this 45-minute documentary exposes the web of threats facing our elections today. The film includes a segment on Indiana’s fight to reform redistricting, featuring interviews with Common Cause’s Julia Vaughn and Debbie Asberry of the Indiana League of Women Voters and co-founders of *All IN for Democracy*, Indiana’s Coalition for Redistricting Reform.
