



Volunteer Release and Waiver of Liability

This Release and Waiver of Liability (the "release") executed on (date) _____ by (the "Volunteer") _____ releases Village Friends Village Values Inc. (VFVV), a non-profit corporation organized and existing under the laws of the State of Alabama, and each of its directors, officers, employees and agents from any and all liability, claims and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise.

The Volunteer desires to provide volunteer services for Village Friends Village Values' subscribers, and the Board of Directors to engage in activities related to serving as a Volunteer. The Volunteer understands that the scope of Volunteer's relationship with Village Friends is limited to a Volunteer position and that no compensation is expected in return for services provided by Volunteer.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless of VF and its successors and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to VFVV. I understand and acknowledge that this Release discharges VFVV from any liability or claim that I may have against VFVV with respect to bodily injury, personal injury, illness, death or property damage that may result from the services I provide to VFVV or occurring while I am providing volunteer services.

2. Insurance: I understand that VFVV does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits of insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of VFVV beyond what may be offered freely by VFVV in the event of such injury or medical expenses incurred by me.

3. Medical Treatment: I hereby release and forever discharge VFVV from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a Volunteer with VFVV.

4. Assumption of Risk: I understand that the service I provide to VFVV may include activities that may be hazardous to me including, but not limited to auto accidents, slips, trips, falls, lifting injuries, loss of personal property, damage to apparel or personal property. As a Volunteer, I hereby expressly assume the risk of injury or harm from these activities and release VFVV from all liability for injury, illness, death or property damage resulting from the services I provide a Volunteer or occurring while I am providing volunteer services.

5. Photographic Release: I grant and convey to VFVV all right, title and interests in any and all photographs, images, video or audio recordings of me or my children or my likeness or voice made by VFVV in connection with my providing volunteer services to VFVV.

6. Other: As a Volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Alabama and that this Release shall be governed by and interpreted in accordance with the laws of the State of Alabama. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of the Release shall not be affected.
