## SANJUANISLANDYACHT CLUB

### New applicant procedure:

The following information is an outline for applying for membership to the San Juan Island Yacht Club. Follow the steps below to start the new membership process. If you have any questions, please call the Vice Commodore, Mike Nachlinger at (360) 378-9566.

- Step one: Review all the materials in this packet. Direct any questions to the Vice Commodore, whose number appears above.
- Step two: Fill out the enclosed membership application. If a couple, signatures of both are required.
- Step three: Contact each sponsor and have them sign the application, and ask them to send their membership recommendation letter to the Vice Commodore.
- Step four: Mail or deliver your application to the Club, along with a check, made out to San Juan Island Yacht Club, in the amount of \$580 to:

- Step five: Your application will be processed per the By-laws of San Juan Island Yacht Club, **Article III Membership, Section 3**, which reads as follows:

Application for Membership. Blank applications for membership shall be maintained by the Vice Commodore as Membership Committee Chair and issued to any member upon request. Completed applications, which must be signed by a Sponsoring Member and a Seconding Member, shall be submitted to the Vice Commodore. Each applicant shall submit with his or her application a check in the amount of the initial installment payment as an application fee. In the event that the application is accepted as set forth below, the application fee shall be applied toward the initiation fee. If the application is rejected, the application fee shall be refunded in full.

After reviewing an applicant's qualifications, the Sponsoring Member and Seconding Member shall each forward letters of recommendation to the Vice Commodore. The Vice Commodore shall present the application to the Board of Trustees for its consideration. Upon approval of the Board, the application shall be presented to the Membership by posting on the Club's Official Bulletin Board, by a general mailing or E-mailing to all Members, or by reading at the next monthly meeting. If no written or verbal objections are received within twenty days thereafter, the application shall be deemed approved and the applicant will be notified to submit the balance of initiation fees and prorated dues. If any objections are received, the Board of Trustees shall make the final decision as to approval or rejection. Upon receipt of the remaining

portion of the initiation fee and prorated annual dues, the applicant shall become a Member and be invited to the next regular meeting for formal induction. If the application is accepted but for any reason the applicant fails to become a Member, the application fee shall not be refunded.

NOTE: The application fee will be deposited upon receipt. The current Membership cap is set at 202 and there must be a position open for a new applicant to be accepted as a Member. The waiting period may be several months. During that time applicants will be welcomed as guests.

- Step six: Your sponsors will meet with you to acquaint you with our Club and its activities, and to explain what is expected of you as members.
- Step seven: When you are notified that your application for membership has been approved, the balance of the initiation fee (if not paying by installments), and annual pro-rated dues will need to be paid in order for your induction to proceed.
- Step eight: Induction into the Club usually takes place at a regularly scheduled membership meeting following your second reading and the payment of the balance due. At that time you will be formally introduced to the membership as a new member and be given a membership kit. That kit will include a Club burgee, nametags, aprons, and a Certificate of Membership

## **SAN JUAN ISLAND YACHT CLUB**

The Club opened its new facility in the Port of Friday Harbor January of 1987. We have reciprocal agreements with over 120 Yacht Clubs ranging from Alaska to Hawaii to San Diego. The Club is managed for the members by the Board which includes the elected officials including the Commodore, Vice-Commodore, Rear-Commodore, Fleet Captain, Secretary, Treasurer, the Immediate Past Commodore and six Trustees elected from the general membership. The Club membership is capped at 202 memberships. A couple counts as one membership. The Club offers three classes of membership outlined below.

Regular Member (R). A Regular Member shall be defined as anyone 21 years of age or over, who either resides in San Juan County or regularly moors his or her boat in San Juan County for at least 60 days per year. Member must own at least one half (1/2) interest in a sail or power-driven vessel suitable for racing or cruising. Regular membership shall be by selection and upon payment of initiation fees and dues in accordance with the By-Laws as hereinafter provided. Regular members are entitled to vote and hold office. In the event that a Regular Member becomes a non-boat owner as defined above, he or she shall after 5 years of being a non-boat owner, automatically become an Associate Member.

Associate Member (AM). An Associate Member is a non-boat owner with membership by selection and upon payment of fees and dues. Those members selected as Associate Members will be limited to 25% of the total memberships and may vote but not hold offices of Commodore, Vice-Commodore, Rear-Commodore or Fleet Captain. An Associate Member who becomes a boat owner as defined above shall automatically become a Regular Member.

Non-Resident Member (NR). A Non-Resident Member shall be defined as anyone 21 years of age or over, who neither resides in San Juan County, nor regularly moors his or her boat in San Juan County for more than 60 days per year. Unless both conditions are met, applicants will be considered for Regular Membership. Non-Resident Members may vote, but may not hold office.

The following information outlines benefits to members by belonging to the San Juan Island Yacht Club. As a candidate applying for membership, you may want to review these benefits carefully as you make your decision to join our organization.

### Objective

The Club is organized for the purpose of encouraging and supporting all forms of yachting in the Northwest, and to bring members together to share matters of common interest and to further safer and more enjoyable boating.

### Clubhouse

The San Juan Island Yacht Club is centrally located in the Port of Friday Harbor. All members are welcome to take part in all activities planned for the membership at the clubhouse. The clubhouse features a large banquet room, bar and lounge, well equipped galley, rest rooms with showers, and management office. The clubhouse is staffed with a club manager on duty year round with posted hours to assist the membership with their activities. The lounge features a full service bar.

## Activities

The clubhouse has scheduled hours when the lounge and dining room are open.

There are many scheduled social events throughout the year. These events are for the entire membership and their guests. The events include various holiday celebrations and the monthly membership meetings. Members volunteer to work on the committees to plan and implement the various events, and volunteer participation by all members is critical to the vitality and success of our Club events. New members are encouraged to coordinate with their sponsors when signing up for event committees. This is also the best way to get to know your fellow members and make new friends!

Marine events are scheduled throughout the year. These activities are well attended and bring the membership together at locations near and far. These events include cruises, usually scheduled for two to four days, with occasional longer distance cruises with options as to when to join. The chair of the committee usually selects the destination, which can be a secluded anchorage or a marina with restaurants nearby.

The Club sponsors the Opening Day Parade in May and one major sailing contest each year; the Shaw Island Classic in August.

## Monthly Meetings

The monthly membership meetings are usually held at the clubhouse and dinner may be prepared by the committee, catered, or served in potluck fashion.

## Reciprocals

Your membership in the Club entitles you to reciprocal privileges with other Clubs with which we have an agreement. While cruising by boat or vehicle you can take advantage of the facilities at our list of over 120 reciprocal clubs, with minimal moorage rates.

## Rental Facilities

The clubhouse is available for the members to rent for private parties, wedding receptions and special occasions. Members receive a discounted rental rate. The clubhouse is also available to non-members for rental for private events.

## Fees and Dues

### Initiation Fees

The initiation fee is \$2,500.00 and may be paid by check in one of two ways:

- Option #1: Payment of \$580.00 at the time of application  
Payment of \$1920.00 upon acceptance of your membership by the Club.
- Option #2: Installment Method. This option allows you to pay your initiation fee over a period of four (4) years from the time you join. If you choose this method you will pay a total of \$2,700.00 as follows:  
\$580.00 at the time of application;  
\$560.00 on the first anniversary of your acceptance;  
\$540.00 on the second anniversary;  
\$520.00 on the third anniversary and  
\$500.00 on the fourth anniversary.

### Annual Dues for 2019:

A. If you reside in San Juan County, or if you moor your boat in San Juan County for at least 60 days per year you are a Regular Member:

- Couple:** by check- **\$890**; by credit card - **\$920**;  
by quarterly ACH - **\$225**/qtr; by monthly ACH - **\$75**/mo  
**Single:** by check- **\$535**; by credit card - **\$555**;  
by quarterly ACH - **\$135**/qtr; by monthly ACH **\$45**/mo

B. If you neither reside in San Juan County nor regularly moor your boat in San Juan County for more than 60 days per year you are a Non Resident Member:

- Couple:** by check - **\$625**; by credit card - **\$645**  
by quarterly ACH - **\$159**/qtr; by monthly ACH **\$53**/mo  
**Single:** by check - **\$375**; by credit card - **\$390**  
by quarterly ACH - **\$96**/qtr; by monthly ACH **\$32**/mo

- **Paying by Check:** You may pay your annual dues by check or use your bank's bill pay service. Send checks payable to SJIYC to: SJIYC, PO Box 67, Friday Harbor, WA 98250 or give check to Club Manager Karen.
- **Paying by Credit Card:** Alternatively, you may pay your annual dues by credit card using the amount above which includes a service fee of about 3%. Please fill in the information below or see Karen at the Club.

- **Paying by Quarterly Payments:** A third option is to pay your dues in quarterly installments (January 31, April 1, July 1 and October 1) with an ACH transfer option. The paperwork necessary for quarterly payments is below.



- **Paying by Monthly Payments:** A fourth option is to pay your dues in monthly installments (January 31, and the 15<sup>th</sup> of the month, February through December) with an ACH transfer option. The paperwork necessary for monthly payments is below.

New member's annual dues are prorated monthly based on the date of their membership application approval and are payable at that time. Thereafter, dues are billed at the first of each year and are due and payable by January 31st, of each year. Delinquent dues received after February 1st, shall be assessed a \$50.00 late fee.
