Dog Wagon may or may not be used depending on conditions and where we cast off.

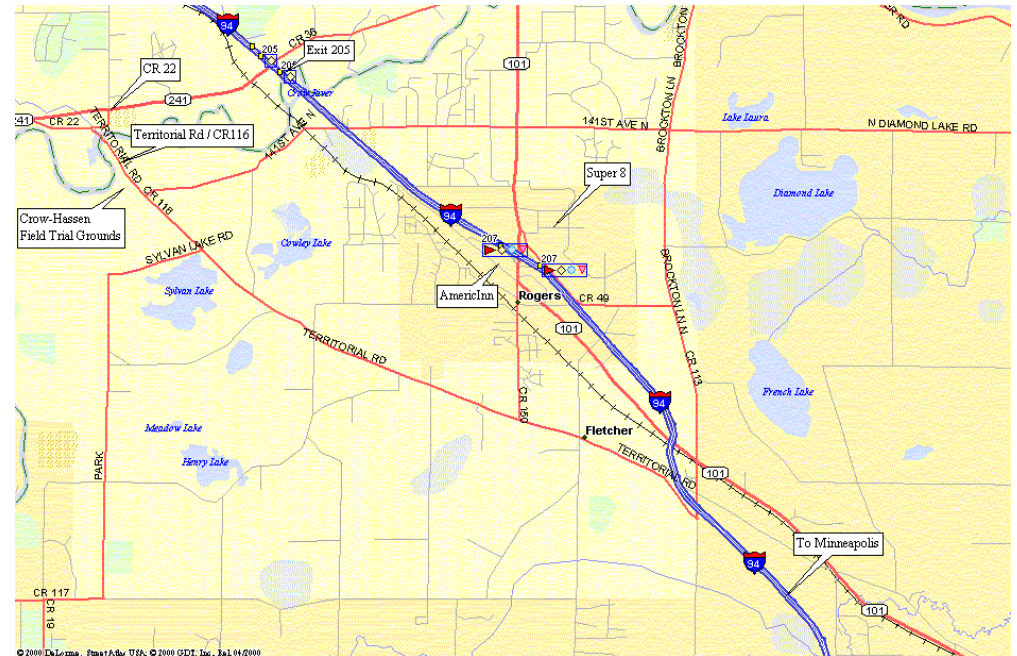
