Release Form

I **AGREE** in consideration for my participation in this Competition to the following:

I **AGREE** that “the Competition” and “Organizations” as used herein includes the IaDCTA, Middle River Ranch as well as all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliates.

I **AGREE** that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death. I **AGREE** to expressly assume all risks of Harm to me or my horse including Harm resulting from the negligence of the Organization or Competition.

I **AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred) the Organization and Competition and for any harm to me or my horse while at the Competition. I have read the rules of the Organization or recommendations by the Organization and Competition about protective equipment and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Organization strongly encourages me to do so while **WARNING** that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child’s participation and **AGREE** to all of the above provisions and **AGREE** to assume all of the obligations of this Release on the child’s behalf.
