**Eligibility:** Open to all artists residing in the United States, 18 years or older. **Wall art only.** No non-hanging art.

**Maximum size 13 inches by 13 inches by 5 inches deep, including frame. No exceptions. All artwork must be original work, no reproductions or copies and cannot have won an award in a previous exhibition at the Mesquite Fine Arts Gallery. Artwork must be priced for sale.**

### DEADLINE FOR PAYMENT AND APPLICATION: MONDAY, OCTOBER 1, 2018

**Entry Procedure:** Entries will be juried into the competition from photos or jpeg digital images. One image per work. Label each with name of artist, title of work, medium, size (including frame), on back of photo, or, for jpeg image, in body of email (vvarts@gmail.com). Email is preferred. Photos will not be returned. **Entry fee is \$13 per piece of artwork and is non-refundable. Make check/money order payable to VVAA.** Two methods of entering:

Once on the linked page, click the "Register Now" button on the screen and follow the prompts. **NO paper entry is required if entering online** (online payment can be made via credit card, or you can mail check/money order to address listed above). **Once online entry is completed, images should be either emailed to [vvarts@gmail.com](mailto:vvarts@gmail.com), subject "Lucky 13, 2018" or mailed to the address indicated above.**

**Notification of juried acceptance of artwork will be emailed to artists by Oct. 8, 2018.**

**Accepted work:** Work can be shipped or delivered to Mesquite Fine Arts Gallery at above address. Please enclose your one-page artist statement/bio. Enclose return prepaid postage/shipping label. Artist is responsible for all shipping costs. **Artwork will be received from Oct. 22 through Nov. 3, 2018.** All work must be suitably framed and presented **with a wire hanger, no saw tooth hangers accepted**. Any work deviating significantly from the original juried photo may be rejected. Artwork must be labeled on back of each piece with name, title, medium and price. The Virgin Valley Artists' Association and Mesquite Fine Arts Gallery volunteers and City of Mesquite will not be liable for any damage or loss of artwork. Submission of an entry to this competition constitutes acceptance of all conditions.

**Hand-delivered artwork must be picked up Dec. 31, 2018 through Jan. 5, 2019 during gallery business hours (10 am to 4 pm Monday through Saturday).**

**Sales:** The VVAA will retain a 30% commission on all sales. The price listed on the entry form will be considered the retail price. An IRS W-9 form is required for sales/awards paid to the artist.
