Rules

The organizing authority and host of the 2019 Flying Scot Dixie Lakes District championships is Western Carolina Sailing Club. This regatta will be governed by RRS 2017-2020, prescriptions of US Sailing, applicable class rules, this notice and sailing instructions.

Eligibility

All Flying Scot skippers are invited to participate, but only members of the Flying Scot Sailing Association who are also members of the Dixie Lakes District are eligible to compete for the Dixie Lakes District Championship.

Registration

Pre-registration by April 5th is encouraged in order to reserve meals. Registration form is attached or you can register online at www.wcsc-sailing.org. Registration fee for each boat is \$85 (\$95 after April 5th). Registration includes: Entry fee and two meal passes for Saturday/Sunday Breakfast, Saturday bag lunch, Saturday night dinner and Sunday travel lunch. Extra meal passes are \$10.

Courses to be sailed

We will sail a windward/leeward course around dropped Marks. The course will be to the west of the WCSC grounds on Lake Hartwell.

Scoring System to be used

Scores will be determined according to RRS 2017- 2020 Appendix A, except that no score will be excluded. The low point system will be used. 6 races are scheduled and 1 race constitutes a regatta.

Awards

Trophies and recognition will be awarded to Dixie Lakes District winners along with overall regatta winners. The places awarded will depend on the number of entries.

Directions

Go North from Atlanta or South from Greenville on Interstate 85. Take Exit 14 (SC Highway 187) and go South on SC 187. When you reach the first traffic light (1.3 miles) turn left on to SC Highway 24. At the next traffic light (2.6 miles) turn right on SC 187 (at the BiLo Store). At the four-way stop sign, go straight. Go one mile to Harbin Drive, turn right. Then turn immediately left on to West Wind Way. Follow to the end of West Wind Way.
