EXPLANATION OF DUES & FEES:

Initiation fees for all classes are payable in full upon application. Dues are payable quarterly in advance. Your first quarter dues and your initiation fee are to be submitted with your application for membership. When a member reaches the age for the next class, he/she will then be obligated for the difference in the initiation fee already paid and the new age class entered. In the event that the applicant withdraws during the probationary period (90 days) or the club decides not to offer a membership, only the initiation will be refunded.
