**Rules:** The organizing authority and host of the regatta is The Western Carolina Sail Club (WCSC). The regatta will be governed by The Racing Rules of Sailing (RRS) 2017-2020 and prescriptions of US Sailing, applicable class rules, this notice and the Sailing Instructions. The regatta is classified as Category A. Measurement certificates will not be required.

**Entry:** The regatta is limited to the following fleets: Lightning, Buccaneer and Highlanders. Each of these fleets will have a separate start and be scored as a fleet.

This event is a scheduled travel series event for the Southeastern Lightning District hosted by Fleet 391 and the Mid-Winters for the Highlander Fleet.

Entrants must complete registration with Western Carolina Sailing Club (WCSC), the organizing authority to be eligible to compete. Each of the 3 fleets shall have their own start.

**Notes:** Race committee may communicate to competitors via VHF in addition to the usual visual and sound signals.

**Trophies:** Trophies will be awarded to the top three boats in each One Design fleet.

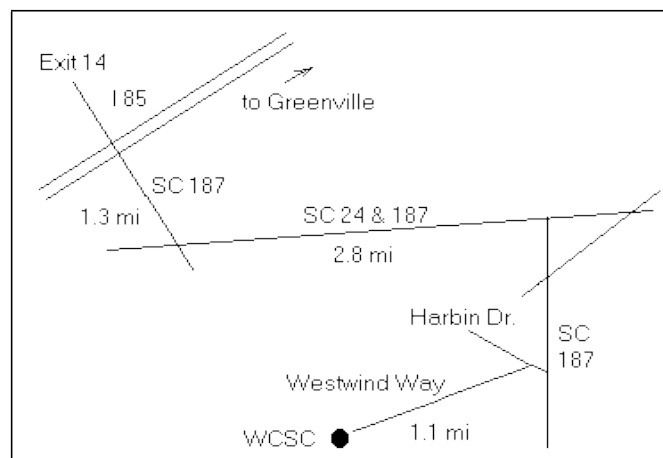
