Then light air took over for two more races. The event this year broadened to include E Scows and M-20s in separate starts. Larry Stewart of Irmo, S. C. was 1st in the E fleet, Harry Carlson 1st in the M-20s. 22 boats came from North & South Carolina, Florida, Georgia and Colorado.
