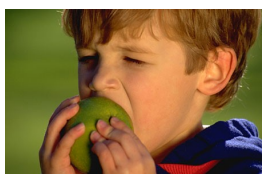


## Does it make sense for you to join?

### CACFP Program Requirements

To qualify for CACFP you must have children enrolled in your program and be a Registered Family Child Care Provider or Licensed Group Family Provider or have submitted an application to be either one. Legally Exempt providers caring for children receiving child care subsidy are also eligible to participate.



**CACFP meals are based on the new Food Guide Pyramid**

- You receive a monthly reimbursement check for a portion of the meals you provide and could include meals served to your own children during day care hours
- You are offered a supply of recipe and nutrition activity resources
- All forms and papers necessary to participate will be supplied by us, your sponsor
- Training and guidance on nutrition standards are available to you when you need them
- Your CACFP Administrator is only a phone call away to answer any questions you may have.

### Reimbursement Rates
