## Strategic Planning

Our work continues! LWVBC Board members have assessed responses to the Board survey and the Member survey (over a third of our members responded...thank you!), and we completed a full day retreat guided by our Strategic Planning consultant.

During our retreat, discussion was geared toward identifying a primary goal. Past successes, existing strengths and weaknesses pointed out in our recent internal surveys, and LWV's given mission were all part of identifying the primary goal to *Increase engagement and participation in LWVBC's activities and mission.*

Then we asked: how do we measure success for our primary goal? How do we accomplish that goal?

Progress indicators, which we will continue to refine, include annual figures such as event attendance, number of outreach efforts to partner or potential partner organizations, number of projects completed, and number of requests for speakers on various issues.

We determined that accomplishing our primary goal requires four focus areas:

- Members
- Supporters (engaging potential members interested in a particular issue)
- Partners (establishing & expanding relationships with other community organizations)
- The broader community

We are considering more emphasis on community educational meetings, teamwork, membership alternatives, administrative structural changes, and how we affect public perception of League. We are embarking on a formal Environmental Scan with emphasis on three community sectors: potential partners, youth, and our Latino population. As we organize these efforts, we will be asking for participation from LWVBC leaders in various capacities.

We are working hard for our organization and looking forward to continuing the strategic planning process through July, as well as benefiting from some great results!

### Member Survey Summary

Thank you to every member who responded to the survey, which was a first step in our League's Strategic Planning process. 35% of members responded on line or by mail. That is a significant response rate and reflects the interest taken in this endeavor. Please note the summary information below.

**59 respondents.** 63% have been members of this League for over 10 years and 20% for under 5 years.
