League Health Care Team Joins Statewide Project on Mental Health

The League of Women Voters supports the right and need for comprehensive health care, including mental health care. Our League of Women Voters of Boulder County (LWVBC) Health Care Team is engaged in a new opportunity to understand and address mental health issues through a statewide project called “Let’s Talk Colorado.”

“Let’s Talk Colorado is a social marketing campaign designed to reduce the negatives around mental health treatment so that people who need this care will access it,” said LWVBC Health Team Leader Mary Anna Dunn.

Our League is one of several sponsors in the coalition, which also includes the Boulder County Public Health Department, from whom we learned about the initiative.



League’s involvement in the project stems from our focus on access to health care for all people. Let’s Talk helps us reduce the stigma of mental illness, e.g. helping us understand the most effective language and approaches with people struggling with mental illness. The project is developing resources (including video, social media content, posters, flyer) to help patients, medical providers and the general public.

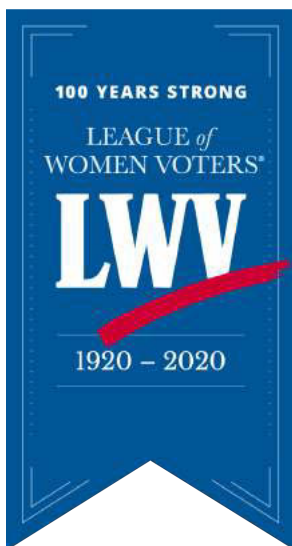
As the League of Women Voters approaches its 100th Anniversary in 2020, leaders from the League of Women Voters of Boulder County (LWVBC) have been planning for our 2017-18 activities to inspire civic engagement and strengthen democracy in our community, as part of our five-year strategic plan that takes us to 2020.

Last month, LWVBC leaders met for a planning retreat focused on "Making Democracy Work for All", which provided the main strategic framework for our plans. **Making Democracy Work for All** is a national and state campaign which focuses on Voter Mobilization, Voter Protection, and Money in Politics. It also includes looking at other opportunities to re-enfranchise voters, such as redistricting reform, alternate voting methods, Electoral College reform, and providing a voice for under-represented people.

As you may know, the League of Women Voters was founded in the same year as the passage of the 19th Amendment, in which women gained the right to vote. One of our greatest strengths as an organization is that we are non-partisan. The League's non-partisanship is providing opportunities to attract new members and to collaborate with other groups working toward solutions for our community, state, and nation. Our non-partisan, position-based approach to advocacy provides new ways for people to ACT to help solve problems on issues we care about. As such, we've stepped up our Community Engagement activities as a major organizational priority, on critical issues like those mentioned above.



We continue our tradition of providing Voter Service for the community, including through voter registration drives, candidate forums for local/school board elections in Boulder County, and information on various ballot issues. We are also planning various events, such as Drinks and Dialogues, Community Conversations, and member meetings such as the Fall Kick-off on September 23. These types of events proved to be quite popular last year, and they are an opportunity to provide education and action in the community. Stay tuned!

I joined the League in 2004, and I have gained valuable experience in leadership, advocacy, and issues facing our community. I am truly honored to now serve as President for such an incredible organization. I look forward to working with LWVBC leaders, community leaders, and all of you to preserve and protect a democratic process that works for everyone in our community.

Mark your calendars for the First Annual LWVCO “Making Democracy Work!” Conference

Are you tired of seeing the impacts of millions of dollars on our elections and legislative process? Do you feel overwhelmed at the scope of this problem? Through the League of Women Voters, you have an opportunity to get informed, and get active to stop the negative influence of money on our democratic system.

For years, our LWV of Boulder County (LWVBC) Campaign Finance Reform Team has worked tirelessly to study and educate Boulder County residents on the ways in which money from a small number of wealthy people influences elections and legislation. Now, at the upcoming LWV of Colorado (LWVCO) conference, “Making Democracy Work!”, we’re deepening our understanding of money in politics, and sharing our League’s leadership at the state level.

Conference participants will hear from campaign finance experts; join roundtable discussion groups; and discuss ways we can take action for elections that are free of undue influence.

Conference speakers will include national expert Lisa Graves, Executive Director of the Center for Media and Democracy, who will inform us on what happened in Wisconsin and what may happen in Colorado when individuals of wealth use their resources to affect elections. Common Cause will present their research on Money in Politics. And we’ll learn how court rulings have undermined our democracy, from a Colorado State University Law professor.

Look for notices from LWVCO soon, and sign up on their website to attend. Together, our local Leagues in Colorado, along with our partner organizations, can work toward solutions to the problem of money in politics, that benefit everyone.

How does the Let’s Talk project relate to our civic engagement goals? LWVBC President Peggy Leech said, “Democracy needs to work for the underserved as well as anyone else. Increasing awareness of mental illness, among our League members and in our community, can help us better advocate for comprehensive health care and assist people struggling with mental illness, to engage in the democratic process.”

According to Dunn, Let’s Talk stresses that there are no right or wrong words to use when talking to someone struggling with mental illness. Instead, the campaign emphasizes being “present” when talking with someone with mental illness and to consider offering tangible, specific help. For example, instead of asking, “What can I do to help?” say, “I’d like to bring you dinner tonight. I’ll drop it off at 5 pm. Will you be home then?” This kind of insight can be helpful as we do our work to engage community members in civic engagement events, voting, and the like.
