“Better Voting Methods” Promises to be a Hot Topic at LWVUS Convention

State and local leagues proposed multiple separate caucuses on voting methods at the national League convention. Due to a limited number of slots, we had to negotiate among ourselves down to two caucuses.

The LWV of Central Delaware County (LWVCDC) in Pennsylvania will hold a caucus on June 28th, the first evening of the convention, because they are advocating for a national study on alternative methods for electing members of the US House of Representatives. One such method is spelled out in House Resolution 3057, The Fair Representation Act (see page 6). The LWV of Sacramento wanted a caucus slot to educate Leaguers about HR 3057 so they may coordinate with LWVCDC on the caucus.

LWVME (Maine) applied for a caucus slot to tell about Maine’s successful fight via ballot initiative to adopt instant-runoff voting (IRV) for the governor, state legislature, and non-presidential federal elections. LWVME also planned to hold an IRV election to illustrate IRV’s superiority over plurality. Note: Maine uses the more generic term “ranked choice voting” or RCV, but RCV can refer to IRV or STV.

Meanwhile, LWVCO proposed a caucus on better single-winner voting methods. Because one of the methods for caucus attendees to experience is IRV, the two state leagues didn’t need to duplicate efforts, and LWVCO will lead the second caucus slot on single-winner voting methods.

In addition, members from our Voting Methods Team will be presenting a caucus at the Convention about alternate voting methods (see article on pages 1 and 6).

We thoroughly enjoyed hearing from **Elisabeth MacNamara**, past President of LWVUS, at our April 11 fundraiser. She gave an inspiring talk: Empowering Voters and Defending Democracy. Many thanks to Louisa Young and Lois Linski for planning this successful event, and to Marlys Robertson for connecting us with Elisabeth.

At its April board meeting, the board voted to support Initiatives 170 and 171, which are the redistricting initiatives that LWVCO has been working on for more than a year. We are now starting to gear up for the elections, especially with the primaries happening in June. This is the first time that unaffiliated voters can vote in the primaries, so there is some voter education needed for that process.

May Drinks & Dialog: Bee Policy


Join the LWVBC Agriculture Team for an informative session regarding what is behind bee colony collapse. Bees are critical to many eco-systems. Bee keepers raise more money from renting out their bees to farms as pollinators than they raise selling honey.

Neonicotinoids (“neonics”) are frequently blamed for losses. The theory is that neonics interfere with a bee’s ability to find its way back to its colony. Other possible culprits are mites that are a pest for bees, disease, and stress caused by frequent transportation to places that rent bees for pollination. Recently bee colony collapse has slowed, but it is still a very serious problem.

What can consumers do? Do agricultural regulations play a role? Speakers will be:

Colorado Redistricting Reform Campaign Update

Two redistricting measures that the League is supporting have passed the state Senate unanimously. SCR18-004 and SCR18-005 went through third reading on April 30th with one amendment that added the word 'independent' to the title seen by the voters.

Now, on to the House....The House first reading and introduction will be Tuesday, May 1 and will be heard in House State Affairs Committee on Wednesday, May 2. FYI: The House sponsors are Speaker Crisanta Duran (D) and Minority Leader Patrick Neville (R). With only a few days left to the session, we hope to report good news very soon.

As we wait for the outcome from this legislative process, please make time to become educated on these two measures. Here is the latest summary information on the two measures. LWVBC Drinks & Dialog speaker Ron Tupa updates members on Redistricting.



The Fair Representation Act proposes multi-member congressional districts, which used to be fairly common. In fact, the first woman elected to Congress, Jeannette Rankin, got the second-most votes in an at-large two-member district in Montana in 1916. Under HR 3057, instead of Colorado's current 7 congressional districts, Colorado would be divided into 2 districts: one with 3 congressional members, the other with 4 members.

HR3057 proposes using single transferable vote (STV), a multi-winner ranked voting method. STV promotes proportional representation – hence, the name “The Fair Representation Act.” STV was used to elect Boulder's city council from 1917 to 1947 and has been used in Cambridge, MA, every 2 years since 1941.

HR 3057 is not expected to pass this year. If and when HR3057 gets signed into law, its congressional redistricting proposal would override whatever congressional redistricting is in effect in every state. The LWVCO president sent her Fair Maps Colorado colleagues a copy of HR 3057 to consider as they worked out their broadly acceptable redistricting plans.

Voting Methods (cont'd)

LWVME will share the story of its alternative voting methods victory during its state report to all the convention attendees, rather than with only a subset who attend a caucus. We hope that LWVME will also recommend the LWVCO caucus to convention-goers.

Look for a post-LWVUS-convention report in the August *Voter*.
