Similarly, we have opened signups for the June 6, 2018 PCBA Professional Responsibility Seminar. As our members know, for the two-year reporting period ending in 2019, at least one of the six Professional Responsibility CLE hours must be in the area of diversity and inclusion, and another one of those hours must be in the area of mental health and substance abuse (Rule 794). The CLE committee has worked very hard to find great speakers for the June 6th seminar, which we believe will provide attendees with two hours of PMCLE credit that meet the new requirements. The mental health segment will be covered by Dr. Ryan Finkenbine, Professor and Chair of the Forensic Psychiatry and Psychology Center at the University of Illinois College of Medicine. and the diversity/inclusion segment will be presented by Justi Miller, an attorney from State Farm in Bloomington. Court News *By Chief Judge Paul P. Gilfillan*

- 1) Attention 10th Circuit family law counsel and litigants: "Children's First" (CF) through ICC is still the required program in the 10th Circuit. The on-line parenting classes, in lieu of CF, may only be used if CF is impracticable and with court permission. Any such permission should be reflected in a court order. If so, then a party may only substitute the on-line program through: www.10thIL.OnlineParentingPrograms.com. Failure to comply with this protocol may result in a party having to repeat the classes.
- 2) Peoria County has installed new electronic dockets at the Main St. and Jefferson St. entrances to the courthouse. They will direct attorneys and members of the public to the case name, courtroom, time of hearing and case number.
- 3) For budget reasons, the Ill. Sup. Ct. has decided not to appoint, in advance, the uncontested November 2018 elected judgeships prior to the swearing in of same on December 3, 2018, absent "extreme extenuating circumstances." This includes the Stark County resident circuit judgeship.

Upcoming Pro Bono Opportunities

2018 Peoria Criminal Record Expungement Summit - Saturday, July 21, 2018 (10am until 4pm) (location to be determined)

Prairie State will be holding another summit in conjunction with Representative Jehan Gordon Booth's office similar to the summit held last spring. During the Summit, pro bono attorneys will meet one-on-one with Summit participants and advise them on their rights, responsibilities and options relating to their criminal history and provide pro se assistance with drafting requests to seal or expunge. Client criminal records will have been obtained and charted by Prairie State. Pro bono attorneys can choose to volunteer all day or pick

a shift from 9am-1pm or 12pm-4pm. We are hoping to have about 40 pro bono attorneys to volunteer this day in order to help as many clients as we can.

Prairie State will provide training for the Summit in early June for Free CLE credit for summit volunteers.
