I hereby waive, release and discharge from any and all claims or liabilities, and agree to indemnify and hold harmless MTL, its officers, directors, activity leaders, trip organizers or members, from any injury, claim or liability (including costs and attorney’s fees) I might sustain at the MTL Lodge or on MTL programs, trips or activities. I attest that I am physically fit and prepared for the possible hazards of these events and activities.
