### **AES 2020 Commercial Exhibit Rules, Regulations and Information**

1. A limited number of commercial exhibit spaces are available in the AES Exhibit Hall at the Downtown Marriott Hotel which is located in Salon III, 7<sup>th</sup> Floor next to the Scientific Sessions Lecture Hall
2. The fee for exhibiting is \$1,750.00 per booth and must be paid in full prior to the meeting.
3. One unit of exhibit space (8'X10' Booth) includes: pipe and drape, ID sign, 1 six foot table, 2 chairs, 1 high rise presentation table and 1 electrical outlet. Table top or portable back wall exhibits are recommended.
4. Exhibit fee also includes: 1 set of meeting materials, 1 free use of an attendee mailing list (distributed by e-mail after the meeting), Continental Breakfast and lunch for 2 on both days and attendance at the President's Reception. Additional personnel may be registered for an additional fee.
5. The AES reserves the right to refuse any commercial display deemed inappropriate to the scientific nature of the meeting. First time exhibitors must be approved.
6. Exhibit materials may be distributed at the exhibitor's booth only
7. All exhibit materials must comply with local fire laws, insurance underwriter and safety regulations. Inherently explosive or flammable materials and substances are not permitted. All electrical work must be installed in accordance with local regulations.
8. All packing materials and containers must be removed from the exhibition area by the time the exhibit hall is open.
9. Exhibitors are required to staff their booth with an attendant during all open hours.
10. AES will provide a security guard during the hours which the exhibit hall is closed.
11. Exhibitor's equipment is not insured by AES for loss, theft, damage or breakage. Neither the Chicago Downtown Marriott Hotel employees or representatives, or any representative of AES can be held responsible for any injury, loss or damage to the exhibitor's employee or property. The exhibitor must assume responsibility for damages to the property caused by, or which in any way arises out of the actions of the exhibitor.
12. Exhibitors who fail to arrive will be responsible for all rentals and no refunds will be issued.
13. The AES will allow the exhibitor to cancel is exhibit space up to four weeks prior to the meeting and will refund 70% of the registration fee. After four weeks no refunds will be granted.
14. All exhibitors who ship materials directly to the hotel, will do so with the AES's contracted exposition service coordinator. Information and an exhibitor registration kit will be sent at a later date.
