- Acknowledge that a failure to maintain membership will result in the loss of fellowship status in the AES;
- Verification of a minimum of 400 AES approved CE hours must be attained during the five years which includes ADA-CERP Providers, AGD-PACE Providers, AMA-PRA Category 1 credit courses, and courses provided by CODA accredited institutions; International Dentists must have equivalent credits approved by their National Registration Body or Educational Authority

  - 100 CE hours will be awarded for a GPR, AAGD, or any approved advanced postgrad program.
  - **Submit a list of courses attended and relevant CE awarded for review.**
- Acknowledge that a minimum of 65 CE hours must be AES sponsored courses. (Annual Meetings, CE Workshops, Digital/Online Learning: Podcasts, Webinars etc.);
  - Current members are allowed to utilize CE hours backdated up to ten years;
