This program provides an opportunity for dental practitioners, laboratory technicians, researchers, dental school faculty, their residents and students from the **member countries** to participate in the AES Annual Scientific Session. **SUBMISSION DEADLINE DECEMBER 31, 2017. The application is a writable PDF. The program is February 21-22, 2018 at the Downtown Marriott in Chicago, IL**

## **DEFINITION OF THE PROGRAM**

The participant's presentation consists of a poster presentation in the format of the International Association of Dental Research. It presents research or clinical findings in a poster presentation form. It includes a hypothesis, methods and materials, results, discussion and a conclusion.

## **ELIGIBILITY**

The participant:

- Must be a dental student, resident, dentist, laboratory technician, dental school faculty or allied healthcare professional at the time of the AES Annual Session.
- Two (2) or more participants may conduct the research for the poster presentation.

## **INVITATION TO PARTICIPATE/RESPONSIBILITY OF INSTITUTE**

An invitation to participate in the Poster Program is sent to the program director each institute. If the program director decides that the institute will participate, he/she will then provide the name of the mentor who will assist the participant in properly fulfilling the requirements of the program.

## **RESPONSIBILITY OF THE FACULTY ADVISOR**

It is imperative that the mentor, who is then appointed as the advisor, ensures that the participant's poster presentation is in compliance with the regulations established by the AES.

Mentor must also ensure the following:

1. Participant makes initial contact with Dr. Lawrence W. Morris via email at [lawrencemorrisdds@att.net](mailto:lawrencemorrisdds@att.net).
2. Participant completes and submits the application, abstract and all other requested information by the due dates.
3. Assist the participant in selecting the appropriate subject in which the participant's poster will be judged.

## **RESPONSIBILITY OF THE PARTICIPANT**

To be eligible for the poster Program, participants must comply with the following:

- Complete and return all forms furnished by the AES
- Submit an abstract or summary (300 words maximum) of the poster presentation that will be presented to Dr. Lawrence W. Morris

## **PARTICIPANT BENEFITS**

### **I. Registration for Annual Session**

AES Central office has been given the name of the participant that will represent their organization and the participant has contacted Dr. Lawrence W. Morris, the participant will be pre-registered.

***Please note:*** If the participant plans to bring along a co-clinician, please inform Dr. Lawrence W. Morris prior to Annual Session so that they will have a registration badge.

**Mentors, please review this form with the participant that is representing your institute.**

### **I. Category I: Clinical Research**

Clinical Research presentations will demonstrate clinical research in various prosthodontics, endodontics, periodontics, surgical or diagnostic procedures, or materials or devices directly related to **occlusal** care. It may include materials that advocate technique or new occlusal applications.

### **Category II: Basic Science Research**

Basic Science Research presentations will demonstrate a method or result of some basic science or molecular biology. It may also show the application of one (1) of the basic sciences (anatomy, microbiology, physiology, biochemistry, etc.) to the art and science of **occlusion**.

### **Method of Selection**

The AES does not designate a specific procedure for the selection of participant. It is acknowledged that each institute has its separate set of rules or guidelines in the selection of the participant. However, it must be understood that the participant who participates in the AES Poster Program must adhere to the regulations established by the AES.

## **REGULATIONS**

### **I. Application Process**

- a) Each participant must initially contact Dr. Lawrence W. Morris via email at [lawrencemorrisdds@att.net](mailto:lawrencemorrisdds@att.net). The application process will begin with contacting Dr. Morris. Participant may contact him either (210) 533-3970 or directly at (210) 535-8827.
- a) After contact has been made with Dr. Morris, each participant must submit an abstract of their poster presentation not to exceed 300 words in length via email at [lawrencemorrisdds@att.net](mailto:lawrencemorrisdds@att.net).

## **I. The Poster Presentation Format**

1. Title
2. Problem
3. Hypothesis
4. Methods
5. Results-The bulk majority of information should be explained here.
6. Conclusion.

## **I. Presentation**

- a) Participant must remain at their assigned poster during the entire session.
  - b) Substitutions of participant or significant changes in the title of the poster presentation from that listed in the official program is not permitted.
  - c) Poster displays must not extend **more than** 7.5 feet wide x 3.5 feet high.
  - d) The oral presentation for each demonstration should be no longer than 10 minutes in length.
- a) Business attire is required for all participants at **all** times.

## **I. Time of Presentation**

- a) Participants must report to the poster area promptly at 7:30AM in order to set up their posters.
- b) Participants must be present the entire time
- c) An open presentation takes place all day Wednesday and Thursday until 5:00 pm.

## **I. Poster Presentations**

The AES will supply the following:

- One (1) poster board to affix the poster presentation. Poster is to be sized 7.5 feet wide by 3.5 feet high.
- Adhesive material to affix poster to back board.
- A sign with the participant's name and table number.

## **I. VIII. Handout Materials**

Handouts are limited to a one (1) page synopsis of the poster presentation. If a student/resident plans to use handout material for their presentation, they should forward a copy to Dr. Lawrence W. Morris by the end of January in order to be reviewed. It is the participant's responsibility to arrange to have sufficient copies of handouts available for distribution.

## **I. IX. Advertising**

No advertising material or material that resembles a commercial promotional effort may be distributed or shown. It is permissible to use trade names (brand or company) for identification purposes only during the open presentation portion of the poster presentations.

**All participants should save all presentation materials and supplies at the end of the day on Thursday. (ie, poster, adhesive material, name plate and table designation plate). Please take these items with you back to your hotel room. Please do not discard or leave any of your items behind at the Poster area.**

All participants receive a certificate of appreciation for their contribution to the scientific session.

## **SHIPPING INSTRUCTIONS**

Information concerning the shipment of materials to the AES may be obtained upon request from the AES Central Office. It is advised to personally carry your poster presentation within a durable poster tube suitable for travel to minimize the possibility of being either damaged or lost in transit. The AES will not assume any responsibility or expense for the shipment of materials to be used in the competition.
