The annual fee may be increased from time to time, and annual Membership may be renewed subject to agreement of the Member(s) and Village Santa Cruz County and payment of the then-applicable annual fee.

TERMINATION OF AGREEMENT: Village Santa Cruz County reserves the right, in its sole discretion, to terminate this agreement, at any time, if the Village determines that it is in the best interest of Village Santa Cruz County, its volunteers, other Members or the undersigned Member(s). If Village Santa Cruz County terminates this agreement, it will return a portion of the fee paid on a prorated basis from the month of termination. The undersigned Member(s) may terminate this agreement at any time by providing **written** notice to the Village. If the Member(s) terminate(s) this agreement, a portion of the annual fee shall be refunded on a prorated basis from the month of termination.
