

2017 Crosscut Family Enduro hosted by North Bay Motorcycle Club

Welcome to the 2017 Crosscut Family Enduro held on Saturday April 1st, 2017. Key time is 9:00am. Be at the starting line at least 15 minutes before your scheduled time.

AMA and D36 cards available at the event.

AMA: \$49 annual or \$20 one day. District 36 \$38 annual or \$10 one day.

We strongly suggest you renew or buy your cards online. Print and bring the receipt. ONLY CASH WILL BE ACCEPTED AT THE EVENT! It will save everyone a lot of time at signups.

Information: crosscut@northbaymc.org or the D36 web site at www.ama.d36.org. Email preferred. We will be at the site from Wed on and there is no cell service. All entrants, family members, and friends must sign an event liability release form.

Sign-in: Participants under the age of 18 must have a parent/guardian present at sign-in to sign a release form. If the parent/guardian is not present at sign-ups there must be a notarized letter from parent/guardian recognizing the individual as such. **THIS WILL BE STRICTLY ENFORCED DUE TO INSURANCE REQUIREMENTS.** Sign-ups will be open from 7-9 pm Friday, and from 6-9 am on Saturday. Riders must check-in to pick up their score card, number plate stickers, helmet sticker, and sign the required release form.

Riders Meeting: There will be a riders meeting at 8:30 AM at the Start line.
Be there! There may be late changes.

Course & Gas: Approximately 40 ground miles. IF YOUR BIKE CAN GO 40 MILES NO NEED TO SEND GAS. **Gas containers must be DOT approved. Last gas trailer leaves at 8:30 AM. Gas trailer across creek at bottom of hill. NO pit crews or spectators at gas.** 4 riders per row. Route sheets will be available at sign-ups. We will try to get the route sheet on our web site and the Dist. 36 site prior to the event. Jart charts will be available at sign-ups. Water will be provided at gas. Even though Cow Mountain will be closed to the public there is always the possibility for two way traffic! **Gas trailer will return to bottom of hill "when safe to return", no set time as there is only one way up/down. Please be patient!**

Equipment: All bikes must pass a tech inspection for spark arrestor, current green/red sticker, proper placement of numbers on helmet/bike, and appropriately secured scorecard. There will be a sound test per AMA rules conducted at tech inspection. No pass, no ride. Helmet, boots, gloves and goggles will be required for all participants. All trails in and out of the staging area will be part of the course, so we do not have a jetting loop. If you need to test go to Middle Creek campground in the Mendocino National Forest, about a 30 min drive.

Camping: There is a \$10 per vehicle gate fee with proceeds going to KCORPS of Lake County. **NO CAMPING OR PARKING WITHIN 60 FT. OF THE CREEK.** This is part of our permit and will be strictly enforced. DO NOT MOVE THE BARRIERS! No Campfires. NO FUEL CANS WITHIN 60' OF THE CREEK! Camping area is primitive/No drinking water available. Please pack out your garbage. Thank you for your cooperation.

General: **Motorcycle riding can be dangerous, Cow Mountain contains some high skill features. It is up to each participant to determine if their skill level is appropriate for this event.** No rider medical insurance. All riders must turn in scorecards so you can be accounted for. We will attempt to do same day results.

Directions:

- **Highway 101 North or South** to Highway 20 East exit. Proceed to Upper Lake and turn south on Hwy 29. Exit west on Scotts Valley Rd. Left on Riggs, right on Scotts Creek Rd.
- **Interstate 5 North or South** to Highway 20 West exit. Approximately 50 miles to Upper Lake. Turn south on Hwy. 29. Exit west on Scotts Valley Rd, Left on Riggs, right on Scotts Creek Road
