## Attachment 1

### Proof of Insurance and Registration

(Reference: BYC By-Laws, Article XV Section 3)

All members who will utilize club facilities, i.e. assigned moorage, guest dock, fuel dock, railway, out station, etc., must carry a minimum of \$500,000 liability insurance on their vessel to utilize the facilities at the Bremerton Yacht Club. The members must have their insurance company provide BYC with a certificate of insurance listing Bremerton Yacht Club as an additional insured with respect to their policy. Current registration in the name of the Club member or members declaring ownership shall also be provided to the Club with annual renewal registration forms provided to the Float Committee by July 1st each year.
