**COMBATTING HUNGER:** The County of Los Angeles is committed to feeding our most vulnerable communities during the Coronavirus pandemic. We are mobilizing public agencies, nonprofits, and volunteers to provide meals to anyone in need during the long months to come. Visit <https://covid19.lacounty.gov/food/> for more information.

- Continue to provide nutritious meals to all students at “Grab & Go Food Centers” at 63 locations from 8 a.m. -11 a.m.
- Issuing additional CalFresh benefits up to the maximum allowed per family and allowing CalFresh recipients to purchase groceries online for delivery from Walmart and Amazon.
- Completed over 99,021 meal and grocery deliveries to seniors and people with disabilities across four current projects.
- To date, the #LetsFeedLACounty initiative has held 9 drive-thru food distribution events, distributing 263 tons of food to 14,634 households.
- 211 food-related calls up 406% from March (2,851) to April (14,486)
- WDACS has experienced a 40% increase in senior meals provided since March.
- DPSS reports a 130% increase in Cal Fresh applications since March
- PHFE reports a 20% increase in WIC applicants since March
- Distribution from the Food Bank’s two distribution centers has increased by 80% compared to the first two months of 2020, and this time last year. For more information [Click Here.](#)
