PROJECT ALPHA CONSENT FORM

The **Parental Consent Form** is a form that parents, or legal guardians of children must sign in order to allow children to participate in activities hosted by Alpha Phi Alpha Fraternity, Inc. All youth and guests (if applicable) under 21 years of age must have a signed form to participate in any activities conducted by Alpha Phi Alpha Fraternity, Inc. No one will be admitted to the workshop without this completed consent form. This form should be brought to the workshop. It is recommended that parents/legal guardians keep a copy of the form and contact the activity leader in the event of any questions or in case emergency contact is needed. Project Alpha is a workshop that provides an environment where young males and females can discuss issues related to their sexuality, manhood/womanhood and relationships. The participants will receive information, learn problem-solving skills, and share their own experiences in both gender-specific and co-ed settings.

During the workshop, participants will receive information on HIV/AIDS, other sexually transmitted diseases, teen pregnancy, religious view on abstinence, virginity, sexting, and condom use. Some of the pictures displayed may contain images of genitalia. Due to the sensitive nature of the content, all workshop participants under the age of 21 need the consent of their parents or guardians in order to attend the workshop.

HOLD HARMLESS AGREEMENT

I understand that participation in the activity involves a certain degree of risk. I have carefully considered the risk involved and have given consent for myself or my child to participate in the activity. I understand that participation in the activity is entirely voluntary and requires participants to abide by applicable rules and standards of conduct. I release Alpha Phi Alpha Fraternity, Inc., the chapter, the activity coordinators, and all employees, volunteers, related parties, or other organizations associated with the activity from any and all claims or liability arising out of this participation.

In case of emergency involving my child, I understand every effort will be made to contact me. In the event I cannot be reached, I hereby give my permission to the medical provider selected by the adult leader in charge to secure proper treatment, including hospitalization, anesthesia, surgery, or injections of medication for my child. Medical providers are authorized to disclose to the adult in charge examination findings, test results, and treatment provided for purposes of medical evaluation of the participant, follow-up and communication with the participant's parents or guardian, and/or determination of the participant's ability to continue in the program activities.
