"Free loading" is not permitted on any club trip. Only participants who have officially signed up and paid for their trip prior to departure are authorized to stay in the provided lodging or participate in trip activities. Any non-trip participant who wishes to join in club activities or stay in DSBC lodging must arrange this with the Trip Leader in advance, in accordance with club policies and procedures. The non-trip participant will be responsible for any applicable fees and must sign a waiver of liability.

CANCELLATION POLICY

I understand that if I cancel my trip, I will be charged a cancellation fee regardless of circumstance and canceling from a trip after the specified deadline I will be liable for any and all additional liquidation cost that the club incurs due to your cancellation.

Participants are encouraged to acquire travel insurance to cover unanticipated situations.

TRAVEL INSURANCE

I have been advised that travel insurance is available that may cover unforeseen events that may occur before and during travel making it necessary to cancel or interrupt my participation in the Dayton Ski & Board Club trip named above. I understand that I risk losing my payments made for this trip and I may incur additional costs while on the trip as a result of unforeseen events. I also understand that pre-existing conditions may not be covered if travel insurance is not purchased within 10 days of the trip deposit date.

RELEASE OF LIABILITY AND WAIVER OF CLAIMS

I understand that the Dayton Ski & Board Club (DSBC) is a volunteer, non-profit organization with membership in the Ohio Valley Ski Council (OVSC). For being permitted to participate in this DSBC event, I hereby acknowledge-for myself, my heirs, executors, and administrators, unconditionally release and forever discharge the Dayton Ski & Board Club, and all of its officers, trustees, trip leaders and member agents who are acting on behalf of the Dayton Ski & Board Club, as well as any person or business connected with or involved in producing the events, from all liability and I hereby waive any and all claims, demands, or actions on account of my injury or death or on account of damages that might occur in route to, participating in, and/or returning from such activities. I realize that certain activities, including snow skiing, have inherent risks and hazards and I accept all responsibility for participating in this event.

I also recognize that I have personal responsibilities as a participant on a DSBC trip. I acknowledge that the Trip Leader (TL) is a volunteer trip participant. In accordance with the policy of the DSBC, he or she will receive a reward for being the Trip Leader. The Trip Leader has agreed to accept the responsibility to handle sign-ups, financials and other responsibilities of coordinating and running the trip. However, it is understood that I, not the TL, retain the responsibility to attend to matters such as lost baggage, stolen articles, broken skis, lost passport, or any disputes between myself and civil authorities as well as any minor complaints that I might have with the lodging proprietors.

I am age twenty-one or over and am a current member of the DSBC or an OVSC reciprocating club. I have read and fully understand the release of liability and waiver of claims, agree to uphold the policies and procedures of the DSBC, agree to pay the full trip costs by the final due date, and acknowledge the penalties for canceling my trip.
