Membership Class	Description	2018
Regular Family (non-sailing)	Shall consist of a husband and wife, or single parent, and all their unmarried children under the age of 25 years as of January 1 each year. Such memberships are entitled to all club privileges, including social events, the right to one (1) vote, to propose and endorse applications for membership, to hold office, and launch their boats from club property. Members are entitled to crew in club races.	\$441.42
Sailing Family	Shall consist of husband and wife, or single parent, and all their unmarried children under the age of 25 years as of January 1 each year. This category shall include same privileges as regular family and include ability of each individual to skipper and/or crew in as many fleets as they choose.	\$557.03
Regular Adult (Individual)	Shall consist of an unmarried man or woman 25 years of age or older as of January 1 each year. Such club memberships are entitled to the same club privileges as those for Regular Family Membership. Members are entitled to crew in club races.	\$341.58
Sailing Adult (Individual)	Shall consist of an unmarried man or woman 25 years of age or older as of January 1 each year. Such club memberships are entitled to the same club privileges as those for Sailing Family Memberships.	\$446.68
Senior Couple	Shall consist of husband and wife 70 years of age or older as of January 1 each year. Such memberships are entitled to all club privileges, including social events, the right to one (1) vote, to propose and endorse applications for membership, to hold office, to skipper or crew on yachts in club sanctioned races and to launch their boats from club property.	\$262.75
Senior Individual	Shall consist of Individual adult 70 years of age or older as of January 1 each year. Such memberships are entitled to all club privileges, including social events, the right to one (1) vote, to propose and endorse applications for membership, to hold office, to skipper or crew on yachts in club sanctioned races and to launch their boat from club property.	\$183.93
Junior Skipper	Shall consist exclusively of persons less than 25 years of age as of January 1 each year, who would not otherwise be included under a Sailing Family Membership. Such club membership shall be allowed no club privileges except as set forth below nor be allowed to vote, to propose or endorse applications for membership or to hold office. Junior Skipper membership shall be entitled to skipper yachts in club sanctioned races and launch their own sailboat from club property providing they are properly sponsored in writing by a regular member over the age of 18 indicating acceptance of financial responsibility. Members are entitled to crew in adult club races.	\$262.75
Junior Crew	Shall consist exclusively of persons less than 25 years of age as of January 1 each year, who would not otherwise be included under a Sailing Family Membership. Such club membership shall be allowed no club privileges except as set forth below nor be allowed to vote, to propose or endorse applications for membership or to hold office. Junior Crew membership shall be entitled to crew on yachts in club sanctioned races, providing they are properly sponsored in writing by A regular member over the age of 18 indicating acceptance of financial responsibility.	\$157.65

Junior Opti	Shall consist exclusively of persons less than 16 years of age as of January 1 each year, who would not otherwise be included under a Sailing Family Membership. Such club memberships shall be allowed no club privileges except as set forth below nor be allowed to vote, to propose or endorse applications for membership or to hold office. Junior Opti Membership shall be entitled to skipper Opti's in club sanctioned races and launch their own Opti sailboat from club property providing they are properly sponsored in writing by a regular member over the age of 18 indicating acceptance of financial responsibility.	Free Year 1 \$262.75 Year 1+
Initiation Fee	Applies to all new membership categories except Junior Skipper, Junior Crew & Junior Opti. Previous members subject to initiation fee if membership lapses for more than one(1) year.	\$105.10
Boat Storage	Winter storage for sailboats at the OLYC.	\$210.20
Dry Sailing Slip	Summer dry sailing slip at the OLYC.	\$ 341.58

MEMBER WAIVER OF OKAUCHEE LAKE YACHT CLUB

Okauchee Lake Yacht Club (herein after OLYC): I/We, the undersigned, being an applicant for admission to the OLYC and have completed the Dues Statement, recognize and understand that participation in the OLYC sailing sponsored events are voluntary, and that participants may incur risks by participating, including the possibility of death or injury. To the fullest extent permitted by law, I/we hereby waive any rights I/we may have to sue the race organizers (organizing authority, Board of Directors, officers, other members, race committee, protest committee, host club, sponsors, or any other organization or official) involved with the event with respect to personal injury or property damage suffered by myself/family or my crew or my child(ren) as a result of my/their participation in the OLYC Sailing sponsored event and OLYC social sponsored events and hereby release the race organizers, social hosts and board from any and all liability for such injury or damage. I/We understand that I/we are responsible for our actions and the actions of my child(ren) while I/we may be participating in the sailing sponsored event on the grounds of the OLYC, and upon Okauchee Lake, and that I/we are solely responsible for deciding whether or not I/we or my crew and my child(ren) participates or continues participating in the event. I/We also agree to be bound by the Racing Rules of Sailing, the rules of the Inland Lake Yachting Association, OLYC Bylaws and by all other rules that govern this event.

I/We represent that we have and will maintain sufficient coverage under our homeowner's or tenants liability policy for any negligent acts of applicant in his/her pursuance of OLYC activities.

I/We further certify that, to the best of our knowledge, the applicant, family members and crews are in good physical condition and suffers no physical, emotional or mental impairment, which would adversely affect my/their ability to safely participate in OLYC sailing sponsored events.
