REGATTA OKAUCHEE LAKE WAIVER

Okauchee Lake Yacht Club / Sailing School Waiver of Liability: I recognize and understand that participation in the regatta is voluntary, and that participants may incur risks by participating, including the possibility of death or injury. To the fullest extent permitted by law, I hereby waive any rights I may have to sue the race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) involved with the event with respect to personal injury or property damage suffered by myself or my crew or my child as a result of my or their participation in this event and hereby release the race organizers from any liability for such injury or damage. I understand that I am responsible for my actions or the actions of my child while I or he or she may be participating in the regatta and on the grounds of the event host, and that I am solely responsible for deciding whether or not I or my crew or my child participates or continues participating in the event. I also agree to be bound by the Racing Rules or Sailing, the rules of the Inland Lake Yachting Association, Okauchee Lake Yacht Club / Sailing School and by all other rules that govern this event.

I/We represent that we have and will maintain sufficient coverage under our homeowner's or tenants liability policy for any negligent acts of applicant in his/her pursuance of OLYC activities.

I/We further certify that, to the best of our knowledge, the applicant, family members and crews are in good physical condition and suffers no physical, emotional or mental impairment, which would adversely affect my/their ability to safely participate in OLYC sailing sponsored events.

I / We further understand that the OLYC is an owner, as that term is utilized under the Wisconsin Recreational Liability Statute, sec. 895.52, Wis. Stats. and as that term was defined / referenced in the *Roberts v. T.H.E. Insurance Company*, 2016 Wis. 20, 367 Wis. 2d 368 case. In addition, I / We understand that this is a bargained for arrangement as that term is referenced in the *Roberts* case and that if I/We desire not to execute this document, we shall apply and obtain approval from the Okauchee Lake Yacht Club Board.

I/We execute this document on behalf of my family, including minor children.

Altering this document in any matter or not signing and completing this document is automatic cause for Regatta disqualification.
