### WHO CAN REGISTER TO VOTE

\*U.S. citizen \*Resident of Florida & Broward County. \*At least 18 years old (16 & 17 year olds can pre-register). \*No felony convictions unless rights have been restored. \*Not be judged mentally incapacitated, unless competency has been restored. \*Voter registration is active if you vote at least once every four years and is transferable from another county in Florida. You must be registered at least 29 days before election day. \*Form available on SOE website or online at RegisterToVoteFlorida.gov.

Contains precinct number and poll location, U.S. House, Florida Senate, Florida House, County Commission and School Board District numbers.

### 3 WAYS TO VOTE

#### EARLY VOTING

All early voting sites are available to all Broward County voters, regardless of precinct. Photo ID with signature required.

#### VOTE BY MAIL

VBM (absentee) ballots may be requested in the State of Florida for any reason at www.browardvotes.gov or call 954-357-7055. Ballots must be received by the SOE by 7pm election day. Outside envelope must be signed and dated. Signature must match official ID.

#### ELECTION DAY

Polls open from 7AM to 7PM. Photo ID with signature required. Voting allowed in your home address precinct only.

### PRIMARY ELECTIONS

Florida is a closed primary state. Only voters registered in a political party may vote for that party's candidates. All Judicial and School Board candidates are nonpartisan. They may be on primary ballots and are available for all registered voters.

### UNIVERSAL PRIMARY SYSTEM

Florida allows all registered voters to vote in the primary when there is no opposing party candidate on the November ballot.
