**PLEASE NOTE – THERE IS A FEE FOR LATE DUES:**

Delegates to the 2009 GWR Spring Conference approved the amendment of GWR Bylaws Article IX, Finance, Section 9.2.e, 1., which reads: *Delinquent Dues and Fees - When any financial obligation of a club is not paid by the July 10 delinquent date, the GWR treasurer shall send a written notice of the delinquency to the club's president and treasurer, with a copy to the GWR governor and district director. Payment of dues received on or after August 1 shall result in the assessment of a late fee of \$50. Payment of dues received on or after September 1 shall result in the assessment of a late fee of \$100.*
