

WIT-NC SPONSORSHIP AGREEMENT

This Agreement for sponsorship is between Women in International Trade- Northern California (WIT-NC), a California 501 (C)(6) non-profit corporation and, located at

WIT-NC will be permitted 30 days to rectify such grievances. Thereafter, if WIT-NC and Sponsor cannot reach a mutually agreeable solution in writing, upon 30 days written request for refund from Sponsor, WIT-NC will issue a refund of the Sponsorship Fee. The refund will be for the full amount if the initial claim is made during the first six (6) months of this Contract, and for one-half of the total Sponsorship Fee amount if the initial claim is made during the second six (6) months of this Contract. The parties agree that no amount above the Sponsorship Fee will be owed in connection with this Contract, and that Sponsor will not request any damages beyond the amount of the Sponsorship Fee.

All trademarks, trade names, and logos related to Sponsor remain the property of Sponsor, and will be licensed to WIT-NC for the purposes of communicating Sponsor's support of WIT-NC.
