Course Information

- This course has been approved to provide three hours of MCLE credit, including .50 credit for ethics and .50 for elimination of bias.

- Prior to attending the Bench Conduct and Demeanor class, attendees must complete two short exercises entitled Self-Monitor Scale and Implicit Association Test. These exercises are for self-evaluation - it is not necessary to save or bring results to class.
- **Parking Instructions:** Attendees may park in the **Victory/Mitchell** lot located at 64 North Market Street, San José, CA 95113. It is on the east side of Market Street across from the San Pedro/Market garage and south of the Downtown Superior Court. **Temporary judges must obtain parking validation for this lot to cover their time at the facility from Administration reception staff located on the eighth floor of the Family Justice Center Courthouse.** Please be sure to bring your ticket with you to obtain validation.

- **Judicial Conference Room:** Enter through the main entrance of the facility, and pass through the security checkpoint. Proceed to the public elevator on the left (the stairs will only go as high as the third floor). Once out of the elevator, walk towards the hall (the restrooms will be the opposite direction), and then turn right towards the windows. The Judicial Conference Room will be on the right.
