Zeoshi Terms of Service

These Terms of Service ("Terms") govern the use of the media transformation services ("Services") offered by Zeoshi, Inc ("Zeoshi", "we", "us" or "our") through www.zeoshi.com. It forms a binding agreement between Zeoshi and you and, if applicable, the company or other legal entity you represent. By using any of the Services, you are agreeing to be bound by these Terms. If you are entering into this agreement on behalf of a company or other legal entity, you represent that you have the legal authority to bind the legal entity to this agreement, in which case "you" shall mean such entity.

Changes

We may alter the Services we offer you and/or choose to modify, suspend or discontinue the Services and this Website at any time and without notifying you. We may also change, update, add or remove provisions (collectively, "modifications") of these Terms from time to time. Because everyone benefits from clarity, we promise to inform you of any modifications to these Terms by posting them on this Website and, if you have registered with us, by describing the modifications to these Terms in an email that we will send to the address that you provided during registration. To be sure we properly reach your email inbox, we just ask that you let us know if your preferred email address changes at any time after your registration.

If you object to any such modifications, your sole recourse shall be to cease using the Services and this Website. Continued use of the Services and this Website following notice of any such modifications indicates you acknowledge and agree to be bound by the modifications. Also, please know that these Terms may be superseded by expressly-designated legal notices or terms located on particular pages of this Website. These expressly-designated legal notices or terms are incorporated into these Terms and supersede the provision(s) of these Terms that are designated as being superseded.

Registration for Services

You may be required to register and pay for certain use of and subscriptions to the Services. If you want to create a Zeoshi account with us, you must submit the following information through the account registration page on this Website:

- A working email address.
- First and last name.
- Password.
- Company name and phone number.

You may also provide additional, optional information (such as what products you are interested in) so that we can provide you a more customized experience when using this Website –but, we will leave that decision with you. Once you submit the required

registration information, we alone will determine whether or not to approve your proposed account. If approved, your account will be created. For so long as you use the account, you agree to provide true, accurate, current, and complete information which can be accomplished by logging into your account and making relevant changes directly or contacting us using the below contact information and we can make the changes for you. And, if you forget your password — no worries as we will happily send a password update to your provided email address.

You are responsible for complying with these Terms when you access this Website or use the Services, whether directly or through any account that you may setup through or on this Website. You are solely responsible for all activities under your account. Because it is your account, it is your job to obtain and maintain all equipment and services needed for access to and use of these Services as well as paying related charges. It is also your responsibility to maintain the confidentiality of your password(s), including any password of a third-party site that we may allow you to use to access the Services. Use of Service

Media Content means all content, (data, video, templates or information in any form that is uploaded to or made available to us in your Account(s). You have no other rights in this Website or the Services and you may not modify, edit, copy, reproduce, create derivative works of, reverse engineer, alter, enhance or in any way exploit any of this Website or the Services in any manner. If you make any copies of this Website while engaging in Permitted Purposes then we ask that you be sure to keep on the copies all of our copyright and other proprietary notices as they appear on this Website.

You may not use any "deep-link", "page-scrape", "robot", "spider" or other automatic devices, program, algorithm or methodology, or any similar or equivalent manual process, to access, acquire, copy or monitor any portion of the Website or any Services, or in any way reproduce or circumvent the navigational structure or presentation of the Website or any Services, to obtain or attempt to obtain any Services, documents or information through any means not purposely made available through the Website. Zeoshi may terminate any free Services at any time without notice, in its sole discretion. NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THIS AGREEMENT, ZEOSHI'S FREE SERVICE IS PROVIDED "AS IS" AND WITHOUT ANY REPRESENTATION OR WARRANTY OF ANY KIND.

Termination

You may terminate this Agreement at any time by closing your Zeoshi account. For free accounts, we may terminate this Agreement for convenience at any time. For paid accounts, we may terminate this Agreement on sixty (60) days' notice given by email to the address of your Zeoshi account. We may terminate this Agreement immediately upon our notice to you for any breach of this Agreement. The proprietary rights, disclaimer of warranties, representations made by you, indemnities, limitation of liability and general provisions shall survive any termination of these Terms.

Media content

You are solely responsible for any Media Content that you submit to the Services. By submitting any Media Content, you are promising us that:

- You own all rights in your Media Content (including, without limitation, all rights to the
 reproduction and display of your Media Content) or, alternatively, you have acquired all
 necessary rights in your Media Content to enable you to grant to us the rights in your Media
 Content as described in these Terms and as necessary to provide you the Services;
- You have paid and will pay in full all license fees, clearance fees, and other financial obligations, of any kind, arising from any use or commercial exploitation of your Media Content:
- Your Media Content do not infringe the copyright, trademark, patent, trade secret, or other intellectual property rights, privacy rights, publicity rights, or any other legal or moral rights of any third party;
- You voluntarily agree to waive all "moral rights" that you may have in your Media Content;
- Any information contained in your Media Content is not known by you to be false, inaccurate, or misleading;
- Your Media Content does not violate any law (including, but not limited to, those governing export control, consumer protection, unfair competition, anti-discrimination, or false advertising);
- Your Media Content is not, and may not reasonably be considered to be, obscene, sexually
 explicit, defamatory, libelous, hateful, racially, ethnically, religiously, or otherwise biased or
 offensive, unlawfully threatening, or unlawfully harassing to any individual, partnership, or
 entity:
- Your Media Content does not contain any viruses, worms, spyware, adware, or other potentially damaging programs or files;

• Your Media Content does not contain any information that you consider confidential, proprietary, or personal.

By submitting Media Content, you grant to us a limited, revocable (as set forth in this Agreement), non-transferable, non-exclusive, fully-paid, worldwide, royalty-free license (sublicensable through multiple tiers) to transcode, use, store, distribute, reproduce, modify (with a right to create derivative works to the extent necessary to perform Zeoshi's services and operations), adapt, publish, transcribe, translate, publicly perform, and publicly display your Media Content (or any modification thereto), in whole or in part, in any format or medium now known or later developed and for all purposes necessary to provide you the Services. You further grant Zeoshi the right to retain your Media Content for the purpose of quality assurance and technical improvement. We may use your Media Content for the sole purpose of transforming and enriching the Media Content and only in a manner consistent with the Permitted Purposes.

We may, but are not obligated to, pre-screen Media Content or monitor any area of this Website through which Media Content may be submitted. We are not required to host, display, or distribute any Media Content on or through this Website and may remove at any time or refuse any Media Content for any reason. We are not responsible for any loss, theft, or damage of any kind to any Media Content.

You agree to indemnify, defend and hold harmless Zeoshi, its parents, affiliates and subsidiary companies, and each of their officers, directors, employees, consultants and agents (collectively, the "Released Parties") from any and all losses, damages, claims, liability, damages and/or costs (including, but not limited to, attorney's fees and other legal costs) arising from your Media Content and your use of the Services, your violation of these Terms, or your infringement, or infringement by any other user of your account, of any intellectual property or other right of any person or entity. Without limiting the foregoing, you agree to hire attorneys to defend the Released Parties if you violate these Terms and that violation results in a problem for us. Local Laws; Export Control
