Protocol/Have a Go Day, Saturday pm

A dressage protocol day is a relaxed, educational day where riders can gain confidence with their training. Class 1 allows you to try a test before a judge, receive immediate feedback, and then ride it, or parts of it again to improve the work or score. Unlike competitions, these sessions are training-focused, no formal attire, no public scoring or prizes, they are ideal for familiarisation with a new horse or rider, to practice a new level, or work on arena craft and technical issues.

You may wish to bring a young horse out for an experience and just have arena time by yourself for a confidence run, practice test ride for the following day, or simply gain exposure to a small, quiet amount of atmosphere, Class 2 is perfect for this. You may bring a lead horse and helper with you to have arena side if required, please enter details and ground fee payment on Evoevents.

Entry Conditions

1. All entries to be submitted via www.evoevents.co.nz draw will be available on EvoEvents.
2. Payment is to be made via Poli upon entering competition. Should Poli payment not be an option please email entries@dressagecanterbury.co.nz & pay into **Dressage Canterbury Account: 02 0820 0359529 00**. Please advise the name of the rider in the reference section.
3. Only entries received and paid for by the closing date will be accepted, otherwise waitlisted for specific classes requested. Entries will not appear on EvoEvents until payment confirmed via bank statement.
4. Withdrawals/Scratchings must be submitted on EvoEvents and the attached form supplied to gain a refund. **Note: Rider Admin fee and Evo online fees are Non-Refundable.**

Competition Conditions

1. **Rules:** All competitions will be run under current updated ESNZ GR's, VR's & ESNZ Rules for Dressage.
2. **Tests:** All tests from DNZ Test book version 2023, V2026 FEI for all FEI tests.
3. **Responsibility:** It is the Rider or Persons Responsible obligation, to read and understand the conditions for this show. Conditions are published in this schedule and the programme.
4. **Amendments:** The OC reserves the right to refuse entries, cancel the event, alter the programme/schedule, combine classes as required. The OC reserves the right to alter the programme to ensure the smooth running of the event. It is the rider's responsibility to check any new times posted or make entry amendments via EvoEvents.
5. **Presentation of Prizes:** See DNZ Rule article 485.
6. **Riders with more than 2 horses:** The OC will make every effort to ensure that riders have at least 60 minutes between rides. However, if this is not possible owing to the scheduling of classes, the maximum time possible between rides will be allocated.

General

1. Approved Dressage NZ Horse/Pony identification numbers must be worn at all times when competing. When not competing, it is compulsory that horses/ponies are identified with ID tags that include the person responsible name and mobile phone number.
2. All yards and stables are to be left properly mucked out. If not, a fee of \$50 will be charged. Please keep wash down bays clean at all times. No form of temporary yarding is permitted. Dressage Canterbury must pay a bond of \$500 to use the grounds and this is only returned if the yards/ stables grounds and facilities are left clean and tidy, please put all manure in muck heaps by the stables.
3. Stallions must comply with ESNZ Article 147 and must be housed in a stable at all times.
4. Moving horses to unallocated yards or stables is prohibited without permission of the OC.
5. No smoking in any buildings or stable areas.
6. Dogs must be on a lead at all times. The owner of the dog will be responsible for the cost of any damage/harm caused by the dog at the competition, and the associated rider will face elimination due to any disregard of these rules.
7. All horses and ponies on the grounds must be entered at the event unless the OC gives express permission otherwise.
8. Any damage to venue facilities to be reported immediately to the Office.
9. Approved and tagged safety hats must be worn at all times when riding at the Dunstan Horsefeeds NEC.

Health & Safety

1. Dressage NZ and Dressage Canterbury are committed to providing and maintaining a safe and healthy event for all participants, and to providing the information, training and supervision needed to achieve this.
2. Competitors must comply with appropriate Legislation and Health & Safety at Work Act 2015.
3. Each Competitor and/or exhibitor must supervise and control their animals at all times and shall be liable for any hazard created, accident, illness or damage caused by the action of themselves at the venue of the Event.
4. All competitors and associated visitors to the venue must abide by the ESNZ/Dressage NZ Rules, the Dressage Canterbury and Dunstan Horsefeeds NEC Health & Safety Policies.
5. Copies of the event Health & Safety policy can be found at the event office.
6. Any incident or near miss must be reported to the event office and an incident form completed.
7. Any hazards identified must be reported to the event office.
8. Competitors will be responsible for their safety at all times and must observe safe practices and follow event rules and officials' instructions at all times, ensuring that others are not put at risk by their actions.

ESNZ Concussion Policy

This event will be run under the ESNZ Concussion Policy Guidelines. Dressage NZ policy requires all riders to report to the Medical Officer or Steward following a fall. Medical clearance must be obtained before remounting or competing.

Competitors and spectators attending this event do so at their own risk. Neither Dressage Canterbury nor any representative of these bodies, accepts any liability for any loss, damage, injury or illness to horse/pony/rider, spectators, land, vehicles or any personal property whether caused by their negligence or breach of contract in any way whatsoever. Dressage Canterbury shall not be liable for the safety of any goods/equipment or the loss of, or damage to such goods and equipment, brought in/stored at the venue, during the period of use.

It is the riders, or person responsible's obligation to read and understand the conditions for this event as published in this schedule.
