

# **Video Interviewing (Idealinterviews) Terms**

IdealTraits Inc. Video Interviewing add-on, otherwise known as Idealinterviews, is designed to enhance your applicant tracking experience. The purpose of this tool is to enable employers and recruiters using our Applicant Tracking System (ATS) to create and send one-way video interviews to candidates who have applied to their job openings. The Video Interviewing add-on streamlines the hiring process, allowing for a more efficient and effective evaluation of candidates.

# 1. User Responsibility
