


FBA Fees

When a Fulfillment by Amazon (FBA) sale occurs, selling fees and FBA fees will be charged according to the Amazon Services Business Solutions Agreement.

FBA Fees Details

A Storage fees

The cubic volume of all products stored in the Amazon fulfillment center is calculated based on their measurements (*1), and the actual amount of space required for storing the products. Fees are calculated on a daily basis for each fulfillment center. The following storage fees are charged per month only for the actual amount of space used. (*2)







Calculation formula: JPY 7.800 \times { (35.5 \times 22.5 \times 11.4) / (10 \times 10 \times 10) } \times (30 [Storage Days] / 30 [Days in the Month]) = JPY 71.024




B Fulfillment fees

The fulfillment fees include picking and packing your orders, shipping and handling, customer service, and product returns. Depending on the product's (1) Price, (2) Size and Weight, the Fulfillment fee is divided into the four categories of [Oversize Product], [High Value Product], [Standard Product], [Small Product].

- * It is necessary for the sizes of all three sides of the product (including packaging), when sorted in the order of (1) the longest side, (2) the second longest side, and (3) the shortest side, to meet the size standards. For example, the shortest side (3) of a package 21 x 21 x 21 x 21 in size would exceed the 20cm limit for the shortest side (3) of a standard-size product, so it would be handled as an oversize product. **The FBA service cannot be used with packages for which 1) the total of the three sides exceeds 200cm, 2) the total of the three sides exceeds 170 cm (including 170cm) and any side exceeds 90cm (including 90cm).
- or 3) the packages that exceed 40kg.

Other FBA fees

Additional FBA fees are applied when using the following services. Refer to the Help page on the Seller Central website for more details. All of the following fees include consumption tax.

■ Premium Placement Fees *7

Premium Placement is an optional service that allows the seller to specify one Amazon fulfillment center to which to send consolidated FBA shipments. The following fees are charged when this service is used.

^{*7} Please note that even with Premium Placement, certain products for which the fulfillment center has been predetermined—including those in the categories of apparel, fashion accessories, shoes, bags, jewelry and watches, as well as products with special handling requirements (such as flammable hazardous materials)—may still need to be shipped to other fulfillment centers.

■ FBA Labeling Service Fees

FBA labeling service is an optional service in which Amazon labels products on behalf of the seller. The following fees are applied when this service is used.

■ Long-Term Storage fees

On February 15 and August 15 of every year, FBA conducts an inventory cleanup. On these dates, inventory that has been in Amazon fulfillment centers for 6 months or longer will be charged a long-term storage fee per 1000 cubic centimeters (10cm x 10cm x 10cm).

These fees are applied when cash-on-delivery has been specified for FBA Multi-Channel Service orders.

■ Unplanned Prep Service Fee

When products that have not been prepped or labeled in compliance with the Inventory Requirements are sent to Amazon, we complete unplanned prep services, such as labeling or poly bagging within our fulfillment centers. For select activities, FBA charges Unplanned Prep Service fees, which are reported and charged per unit. You can view a list of products that have been charged the Unplanned Prep Service fee in the Summary tab of the shipment creation workflow and in the Inbound Performance report.

FAQ: Frequently Asked Questions

What charges apply when the Fulfillment by Amazon contract is established?

No charges apply when the Fulfillment by Amazon contract is established. Storage fees apply from the moment when products are received at the Amazon fulfillment center. Fulfillment fees also apply when products are shipped to customers after orders have been received.

Who pays the cost of sending my products to Amazon fulfillment centers?

The costs of sending products to Amazon fulfillment centers are to be paid by sellers.

When are storage fees and fulfillment fees charged?

Payment occurs in accordance with each individual payment cycle set in the seller account when the contract is established between the seller and Amazon.co.jp. Fulfillment by Amazon storage fees based on the counts of days during which products are stored. FBA storage fees are applied when the Amazon fulfillment centers receive the products, and are charged on a monthly basis. Storage fees are calculated for the previous month between the 7th and 15th of each month and billed at the time of the next payment. Fulfillment fees apply for each product shipment after orders have been received, with payment occuring together with other FBA fees in accordance with each individual payment cycle. ^{*6 :} The fulfillment fees for the FBA Multi-Channel Service are calculated in accordance with the size of the product
