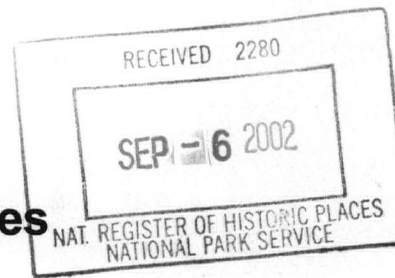

SIGNIFICANCE

The 1940 Maitland Arroyo Bridge on Colorado Highway 69, three miles northwest of the junction of Interstate Highway 25, meets the registration requirements under Criterion A in the areas of Transportation and Politics/Government and under Criterion C in the area of Engineering as set forth in the *Highway Bridges in Colorado*, Multiple Property Documentation Form. The period of significance begins in 1940 with the completion of the bridge and extends through its historic use to 1952, a date fifty-years-of-age in keeping with National Register criteria.

This timber/concrete bridge carries paved State Highway 69 over Maitland Arroyo in rural Huerfano County northwest of Walsenburg, the county seat. Its construction was proposed by the county late in 1939 as part of "extensive improvement of mine roads and secondary highways" in the county.

During the 1930s the Great Depression devastated the nation's economy, leaving millions jobless and homeless. By 1933 more than 13 million workers were unemployed, more than a thousand homes were being foreclosed upon each day, and cities and counties across the country were bankrupt. In an effort to alleviate the financial distress, at least in part, President Franklin Roosevelt established a variety of federal agencies whose primary purpose was to funnel billions of dollars of relief money to the destitute citizenry. A favored way of distributing funds to the unemployed was by means of so-called make-work projects directed toward maintaining national forests and parks, producing artwork for public places, writing tourist guides, documenting historic sites, constructing buildings, irrigation works, dams, roads, bridges, etc.

To administer all of this activity, the Roosevelt administration established such bureaus as the Civilian Conservation Corps and the Work Projects Administration (later renamed the Works Progress Administration). In Colorado the WPA employed as many as 43,000 workers at one time on projects that ranged from sewing and writing to landscaping urban parks, constructing libraries and hospitals, and grading roads. According to *The WPA Worker*,

The vast panorama of roads and bridges, of new school houses and additions, or sidewalks and curbs, of unsightly trash holes covered and landscaped into scenic spots, of new camping nooks in the mountains, of flood protection in retaining walls and rip-rapping, altogether have set this state ahead by many decades.

Engineering

In December 1939, the Works Progress Administration (WPA) approved some \$119,000 worth of construction. The following year several WPA work crews commenced work on roads

throughout the county. As part of the work, WPA built several small drainage structures, but two of the largest and most impressive structures built in 1940 were this multiple span timber stringer bridge over Maitland Arroyo and a steel stringer bridge over Missouri Creek (5HF1894) about a mile away.

Most of Colorado's WPA built bridges were constructed around 1935-1937. Early in 1937, for instance, WPA workers built seven bridges in Huerfano County to replace structures that had been washed out by flooding. However, a few noteworthy structures were completed during the waning years of the program. This large scale structure in Huerfano County fits within this latter group. It is distinguished by its multiple spans, its combination of WPA rustic work and Colorado Highway Department (CHD) bridge construction, and its exceedingly high degree of physical integrity.

Designed by CHD, the Maitland Arroyo structure was comprised of six 20 foot spans, supported by stone masonry abutments with angled wingwalls and CHD standard concrete spill through piers. The timber deck was flanked on both sides by timber beam guardrails. Since its completion, the Maitland Arroyo Bridge has functioned in place without subsequent alteration.

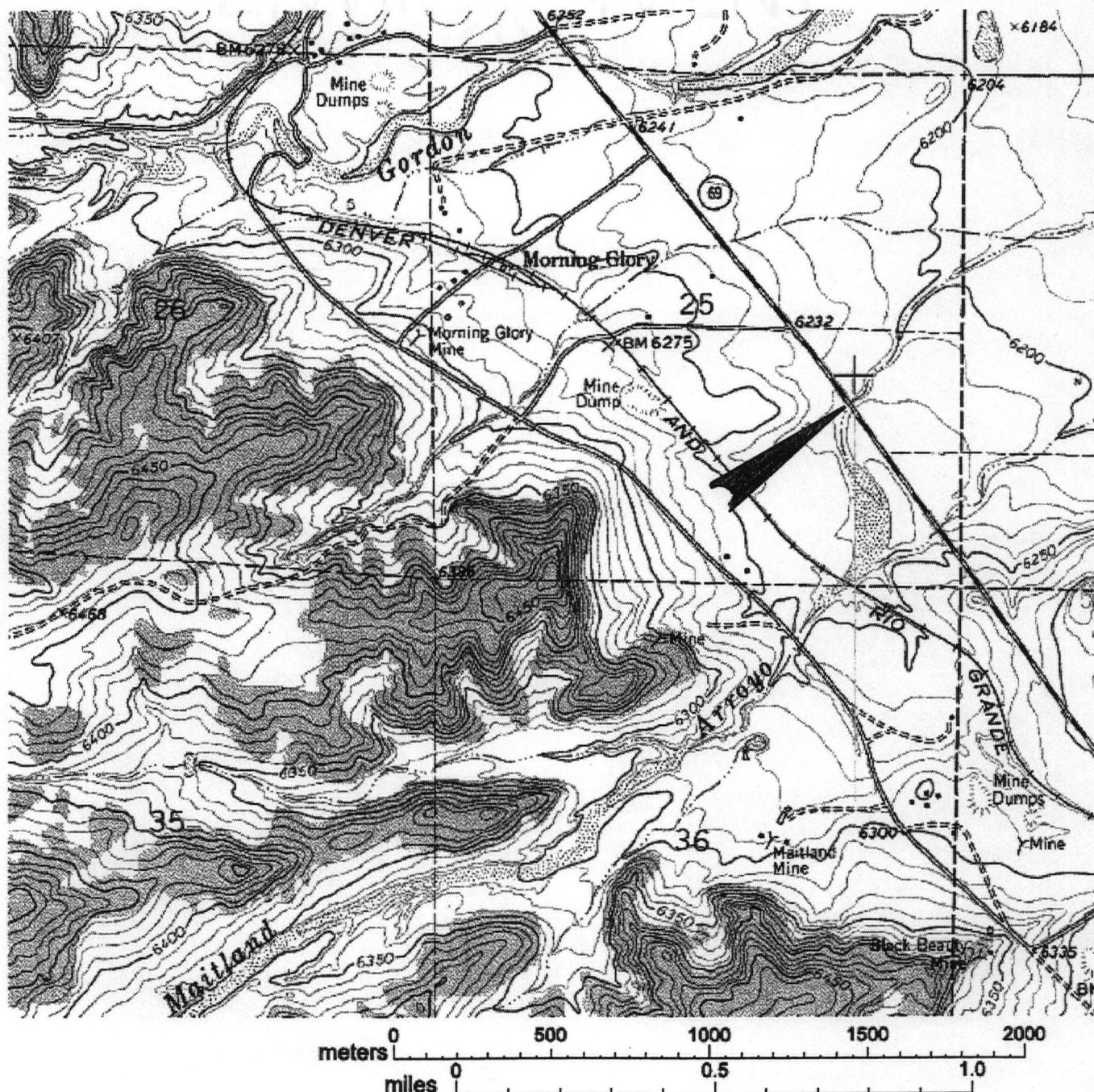
