Describe present and historic physical appearance.

The historic Westcliff Schoolhouse is the only building in Westcliffe of the design which is locally known as the Cottage style, a variety of front gabled vernacular masonry. The schoolhouse faces east on 4th Street, and is situated next to the city park. The landscape is informal with mature trees growing close to the building on the south side. Two outhouses are in the back and a wooden fence encloses the front yard. Three flag poles are in the front of the school where on special occasions, the American flag, Colorado State flag and the Centennial flag are flown. Westcliffe is located in the Wet Mountain Valley, west of Pueblo. Originally founded in the late 1800s as a mining community, it has become a ranching community and is distinctly rural in character.

The structure is one story however the roof is constructed so that a second floor could be added inside. The building plan is rectangular with a symmetrical facade. The school is constructed of field stone and dark stone quoins accent all four corners of the school. Above the wood frame vestibule, in front, are the name of the school and date of construction. On the roof there is a wooden bell tower with a gabled roof set back from the main facade. The original bell in the tower is rung from inside the school. The main entrance in the vestibule has double doors and plain molding.

The shake shingle roof is a decked gable (flat-topped gable) which known as a "Cottage Roof." $\underline{1}$ The gable ends are faced with fishscale shingles.

Wrought iron cresting once accented the deck, but it was removed during the 2nd World War for the scrap iron. The double hung windows have segmental arches with brick voussoirs. The panes were originally four over four but over the years, some windows have been broken out and replaced with fixed panes. The window surrounds are plain with wooden sills. The rear entrance was once enclosed by a vestibule; the coat room has been removed and the plain back door is exposed.

The school has 1200 square feet of main floor. The floors are wide board hardwood, and the walls have narrow painted board wainscot. The walls above the wainscot and on the ceiling are plastered and painted. In the front part of the building, historical exhibits from Custer County were put up in the Centennial year 1987 and have remained up to be added to as material becomes available. Part of the exhibit is a one room school containing desks and old books, student papers, etc.. from the years when the school house was in existence. In the back part of the building to the west, there is a Teen and Community Center which is sponsored by the Valley Park, Recreation and Youth Center Inc. A pool table, benches, kitchen and restrooms have been added. The schoolhouse still retains much of its original integrity of design, materials, setting, feeling and association.

Behind the school are two identical wood frame outhouses which are contributing. The exact date of construction is not known, but they are believed to have been constructed prior to 1939 as evidenced by their design and materials. They are rectangular in plan with gabled roofs faced in wood shingles. The rafter ends are exposed which is characteristic of the teens and 1920s construction. Also typical of that period is the rabbeted style of the wood siding which covers the exteriors of both outhouses. In the center of the front is a plain board door with two small rectangular openings at the top. These are contributing buildings.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The Westcliff Schoolhouse meets National Register Criterion C because it is significant for its design as a 19th century building type and for its materials and method of construction. Not only is the school the only example of Cottage style in Westcliffe but the material is unusual for a school house. The building, built of local fieldstone, is a testimony to the expertise of its stone mason, Archie Scherer. Mr. Scherer worked on several other buildings in Westcliffe, including the City Jail. 1

The schoolhouse is an important part of the community's history many of the town people still living in the area attended this school. The building was built for the town of Westcliffe as part of the one room school system of Custer County, and was used as such until the school system of Custer County began consolidation in 1948. The school was used for grades 1-3 until December 1953 when the consolidation was completed. Several of the retired teachers are still in the area.

The Westcliff School, built in 1891, stands as a memory of the past and a tribute to the one room schoolhouse. The school name, spelled Westcliff, as opposed to town of Westcliffe, and date of construction appear above the front door.

Westcliffe, the county seat of Custer County, is situated in the western part of the county. Most of the retail business is on Main Street in Westcliffe. The county has no population center. It is two-thirds the size of Rhode Island, its population is over 2,000. Many of the people live on ranches that play an important role of the economy, as does recreation and summer residence.

The settling of the Wet Mountain Valley came when a colony of Germans came from Chicago to begin a new life of farming. The search for minerals in the Rosita, Querida, and Silver Cliff areas brought several thousands of prospectors. The founding of Westcliffe occurred around 1885, after Dr. William A. Bell brought the Denver and Rio Grande Railroad from Canon City in 1881. This railroad line, also known as the Silver Cliff branch or the Grape Creek extension, was built to ship silver ore from the mines in the valley, but it terminated one mile west of the booming mining town of Silver Cliff. It is probable that the line stopped short of the mining town in order to raise the property values and establish a new town on the ranch land owned by Bell. Westcliffe, originally known as Clifton, was renamed by Bell after his English birthplace, Westcliffe-on-the-sea. By 1938 the railroad was no longer in operation, but the land that William Bell had sold around the station had become a town on July 25, 1887.

Even though mining had declined, ranching and agriculture had progressed. Westcliffe became the trading center and center of education for Custer County. Today, modern highways, resorts and a ski area bring tourists to the valley which offers some of the most beautiful mountain scenery in Colorado. The Sangre de Cristo Mountain Range presents unending beauty to those who seek new vistas.

The building has architectural significance because it is the only known school building in Custer County constructed of local field stone. In addition the construction and design by stonemason, Archie Scherer, is notable in several respects. His attention to detail, as demonstrated in the quoins and the randomly placed dark field stones which pepper the schools walls, and his artistic use of local materials make it significant for its method of construction.
